**ORDER GRANTING FIRST AND FINAL APPLICATION OF HARNEY
MANAGEMENT PARTNERS FOR ALLOWANCE OF COMPENSATION
AND REIMBURSEMENT OF EXPENSES FOR THE
PERIOD OCTOBER 30, 2018 THROUGH OCTOBER 21, 2019**

Upon the *First and Final Application of Harney Management Partners for Allowance of Compensation and Reimbursement of Expenses for the Period October 30, 2018 through October 21, 2019* [Docket No. 291] (the “Application”); and the Court having jurisdiction to consider the Application pursuant to 28 U.S.C. §§ 157 and 1334; and the Application being a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and it appearing that good and sufficient notice of the Application has been given, and that no other or further notice is required; and after

due deliberation and sufficient cause appearing therefor, the Court finds that the fees and expenses requested in the Application are reasonable, were necessary and benefited these bankruptcy estates,⁶ it is

ORDERED that the Application be, and it hereby is, granted as set forth herein; and it is further

ORDERED that final compensation and reimbursement of expenses to Harney is hereby allowed and approved in the aggregate amount of \$470,345.74 in fees for the Application Period, consisting of \$65,012.50 in hourly fees and a \$405,333.24 Transaction Fee, and reimbursement of \$7,878.66 in expenses incurred during the Application Period; and it is further

ORDERED that Harney is hereby authorized to draw down the Retainer in the amount of \$54,758.74 in partial satisfaction of the fees and expenses approved herein, with the balance to be paid from the Administrative Reserve; and it is further

ORDERED that the Court retains jurisdiction over this Order and the matters addressed herein.
