Dear Presiding Judge

This is to file a formal complaint and ask for a refund from Sofa Express for a faulty chaise lounger that I purchased and received on Thursday, October 25, 2007 A total of \$540 79 had to be paid prior to receiving the chaise. As soon as we brought the chaise home, set it up and sat in it, it was noted that a peculiar odor (believed to have been some kind of chemical used on the fabric), and a safety issue with the chaise's balance (it would tip over with the slightest touch to the back of the chair) were immediate problems. This information was communicated to the Rivergate Sofa Express Store on the following Monday when I spoke with my salesperson She dispatched a service technician who inspected the chaise and he recommended that it be picked up for repair It was picked up on Monday, November 19 It was scheduled to be returned on Thursday, December 6, however, no one called or came by to deliver the lounger One Friday, December 7 when I called the corporate office to inquire about the delivery, I was informed that the person who could give me the information on the delivery was out and would get back with me that evening She never called back. In the meantime on that Friday, I called Jeannie back and she gave me the bankruptcy news Prior to the bankruptcy filing date, I had asked for a refund several times, but was told to follow protocol Today, the chaise was finally returned in the same condition in which it left. Nothing had been done to correct the problems at all The chaise was just being held under the pretense that it would be fixed I knew when it left that it could not be corrected based on its curved construction, and communicated this sentiment to the corporate office, but I had to follow instructions


