FIRST MONTHLY FEE APPLICATION OF FORCE 10 PARTNERS, LLC, FINANCIAL ADVISOR TO THE DEBTORS, FOR ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF EXPENSES FOR THE PERIOD <u>FROM SEPTEMBER 6, 2019 THROUGH SEPTEMBER 30, 2019</u>

Force 10 Partners, LLC, financial advisor to Sugarfina, Inc., a Delaware corporation and its affiliated debtors and debtors in possession (collectively, the "<u>Debtors</u>"), hereby submits its monthly fee application (the "<u>Application</u>") for entry of an order pursuant to section 331 of title 11 of the United States Code, 11 U.S.C. §§101 <u>et seq</u>. as amended (the "<u>Bankruptcy Code</u>") and the *Order Establishing Procedures for Interim Compensation and Reimbursement of Professionals* (Docket No. 198), granting interim allowance of 80% of fees in the amount of \$97,439.60 and 100% of expenses in the amount of \$2,458.33 for the period from September 6, 2019 through September 30, 2019 (the "<u>Compensation Period</u>"), and in support thereof, Force Ten Partners, LLC respectfully represents as follows:

JURISDICTION AND VENUE

The Court has jurisdiction over this Application pursuant to 28 U.S.C §1334.
This is a core proceeding pursuant to 28 U.S.C. §157(b)(2).

Venue of this proceeding and this Application is proper in this District pursuant to
28 U.S.C. §§1408 and 1409.

3. The statutory predicate for the relief sought herein are sections 327(a), 330, and 331 of the Bankruptcy Code, Bankruptcy Rule 2016, and Local Rule 2016-2.

BACKGROUND

4. On September 6, 2019, the Debtors filed their respective voluntary petitions for relief under Chapter 11 of the Bankruptcy Code. The Debtors are operating their businesses as debtors in possession pursuant to section 1107(a) and 1108 of the Bankruptcy Code.

5. On September 24, 2019, the Debtors filed its *Application for an Order Authorizing the Retention and Employment of Force 10 Partners LLC as Financial Advisor Effective Nunc Pro Tunc to the Petition Date* (the "<u>Retention Application</u>") (Docket No. 141) pursuant to the terms of its engagement letter dated as of September 6, 2019, a copy of which was attached to the Retention Application as Exhibit B.

6. On October 10, 2019, the Court entered an *Order Authorizing the Debtors to Retain and Employ Force 10 Partners LLC as Financial Advisor Effective Nunc Pro Tunc to the Petition Date* (Docket No. 326), which authorized the Debtors to pay and reimburse Force 10 Partners in accordance with the Retention Application.

RELIEF REQUESTED

7. By this Monthly Fee Application, Force 10 Partners requests interim allowance of 80% of its fees and reimbursement of 100% of expenses incurred during the Compensation Period in connection with the services provided to the Debtors.

WHEREFORE, pursuant to the Interim Compensation Order, Force 10 requests payment of 80% of its compensation in the amount of (i) \$121,799.50 on account of actual, reasonable and necessary professional services rendered to the Debtors by Force 10 and (ii) reimbursement of actual and necessary costs and expenses in the amount of \$2,458.33 incurred on behalf of the Debtors by Force 10.

WHEREFORE, pursuant to the Interim Compensation Order, Force 10 requests payment of compensation in the total amount of \$99,897.93 (representing 80% of the total fees (\$97,439.60) billed and 100% of the expenses (\$2,458.33)) incurred on behalf of the Debtors by

Force 10.
