- 1. On September 6, 2019 (the "<u>Petition Date</u>"), the Debtors filed voluntary petitions for relief under Chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the District of Delaware (the "<u>Court</u>").
- 2. On February 21, 2020, Global Apogee filed an unliquidated, undetermined proof of claim, stemming from *Global Apogee v. Sugarfina, Inc., Joshua Reznick, Rosie O'Neill, JOHN DOES 1-10 and BUSINESES 1-10*, filed on June 11, 2018, in the United States District Court for the Central District of California at docket number 2:18-cv-cv-05162-RSWL-E [Claim No. 190] (the "Claim").
- 3. On September 3, 2020, the Debtors filed the *Debtors' First Omnibus Objection* (Non-Substantive) to Certain Claims Pursuant to 11 U.S.C. § 502, Fed. R. Bankr. P. 3007 and

4. On September 3, 2020, the Debtors filed the Debtors' Second Omnibus Objection

(Substantive) to Certain Claims Pursuant to 11 U.S.C. § 502, Fed. R. Bankr. P. 3007 and Del. L.R.

3007-1 (No Liability Claims; Reduce & Allow Claims; Reclassify Claims; and Reduce, Reclassify

& Allow Claims) [Docket 710] (the "Second Omnibus Objection", collectively with the First

Omnibus Objection, the "Objections").

5. On October 7, 2020, Creditor Global Apogee filed its Response in Opposition to

the First Omnibus Objection [Docket 726].

6. On October 7, 2020, Creditor Global Apogee filed its Response in Opposition to

the Second Omnibus Objection [Docket 725].

7. After discussions, the Parties have reached a global resolution and agreed to resolve

the Objections as they relate to the Claim. The Debtors and Global Apogee have entered into a

stipulation (the "Stipulation"), a copy of which is attached hereto as Exhibit A, detailing the

foregoing.

8. The Stipulation was filed on the docket at Docket Number 773.

9. The Debtors and Global Apogee respectfully request that the Court enter the order

attached hereto as Exhibit B approving the Stipulation between the Debtors and Global Apogee.
