**PROOF OF CLAIM – Supplemental information for COMFORT FRIDDLE**

Item 1: Amount of Claim. Interest is calculated at 18% per annum, pursuant to the statutory rate, for the amount accrued as of November 25, 2009, the date the bankruptcy case was filed. Total interest charged in the total is \$53,321.25.
