ORIGINAL COURT DOCUMENT NO. 1585 EXHIBIT, FILED JUNE 22, 2010**



This Order in no way prohibits, affects, or removes any defense to the enforcement of the objecting party's mortgage, whether arising prepetition or postpetition and is further without prejudice to the objecting party's rights, if any, to file a proof of claim, subject to the Debtor's rights, claims, and defenses to said proof of claim.
3. This Order is further without prejudice to the rights, claims, and defenses of the Debtor and its successors or assigns with respect to the enforcement of the objecting party's mortgage.
