DEBTOR'S OMNIBUS OBJECTION #8 TO CLAIMS FOR WHICH DEBTORS ARE NOT

<u>LIABLE</u>

I. INTRODUCTION

The Los Angeles County Treasurer & Tax Collector ("LACTTC") filed amended claim number 3296 on October 12, 2010, in the amount of \$7,365.14. This claim consists of one unpaid bill remaining from LACTTC's original claim number 624, which was filed on December 7, 2009, in the amount of \$158,229.75.

This \$7,365.14 figure, despite Debtor's books and records, is still due and owing to

LACTTC. In addition, LACTTC also filed an administrative claim, Claim Number 3297, in the amount of \$15,746.49 on October 12, 2010. This amount is also still due and owing to LACTTC despite Debtor's books and records.

II. DISCUSSION

LACTTC's original claim number 624, filed on December 7, 2009, included several parcels listed in Debtor's Schedule A filing. Several of these parcels were assessed to the "Federal Home Loan Mortgage Corp.," including the above parcel in dispute. The above parcel, to which the \$7,365.14 in taxes is due, has had this name assessment since January 2009, predating both the bankruptcy case and the debtor's filed schedules. Thus, Debtor has provided no evidence indicating that it is not the proper debtor for this outstanding tax bill. To the contrary, the fact that Debtor has paid off almost all the tax amounts listed in LACTTC's Claim Number 3296, including several parcels assessed to "Federal Home Loan Mortgage Corp.," proves that the remaining debt is properly owed by Debtor and should be paid by them.

III. CONCLUSION

For all the foregoing reasons, Debtor's Omnibus Objection #8, as it relates to LACTTC's amended Proof of Claim No. 3296, filed on October 12, 2010, in the amount of \$7,365.14, should be denied.
