**JOINDER OF MBIA INSURANCE CORPORATION TO LIMITED
OBJECTION OF WELLS FARGO BANK, NATIONAL ASSOCIATION
TO “ORDER APPROVING STIPULATION BETWEEN TAYLOR, BEAN &
WHITAKER MORTGAGE CORP. AND FEDERAL DEPOSIT
INSURANCE CORPORATION, AS RECEIVER FOR COLONIAL BANK”**

MBIA Insurance Corporation (“MBIA”), by and through its undersigned counsel, hereby joins in the *Limited Objection of Wells Fargo Bank, National Association To “Order Approving Stipulation Between Taylor, Bean & Whitaker Mortgage Corp. and Federal Deposit Insurance Corporation, as Receiver for Colonial Bank,”* filed by Wells Fargo Bank, National Association [docket #256] (the “Objection”).

As discussed more fully in the *Joinder of MBIA Insurance Corporation to Certain Motions Requesting the Lifting of Stay to Transfer Servicing Rights and Providing Related Relief*, filed on September 10, 2009 [docket # 185] (the “Lift Stay Joinder”), MBIA is the insurer of the 2006-6 Trust and the 2007-7 Trust (each as defined in the Lift Stay Joinder).

JOINDER TO THE OBJECTION

MBIA generally supports the FDIC Stipulation, and believes its provisions and concessions are necessary to facilitate the proper administration of TBW's estate and to encourage the completion of TBW's Transition Obligations, as defined in the Lift Stay Joinder. MBIA joins in the limited objection made by Wells Fargo in the Objection and believes cause exists to require the limited modification of the FDIC Stipulation before its approval, as discussed more fully in the Objection.
