## SETTLEMENT AGREEMENT

This Settlement Agreement (“Agreement”) is dated as of June 22, 2011 and entered into pursuant to Rule 9019 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”). This Agreement is made by and among the Federal Home Loan Mortgage Corporation in Conservatorship (“Freddie Mac”), Taylor Bean & Whitaker Mortgage Corp. as Chapter 11 Debtor and Debtor in Possession (“TBW” or “Debtor”), and the Official Committee of Unsecured Creditors of the Debtor (the “Committee”) (all parties referenced above, collectively, the “Settling Parties”).

### RECITALS

- A. WHEREAS**, on September 6, 2008, the Director of the Federal Housing Finance Agency (“FHFA”) placed Freddie Mac into conservatorship pursuant to the Housing and Economic Recovery Act of 2008 (“HERA”);
- B. WHEREAS**, prior to its collapse, TBW acted as an authorized “Seller” and “Servicer” of mortgages to and on behalf of Freddie Mac;
- C. WHEREAS**, as of August 2009, TBW acted as servicer for approximately 291,000 mortgage loans owned or guaranteed by Freddie Mac;
- D. WHEREAS**, on or about August 4, 2009, Freddie Mac provided written notice to TBW of termination of TBW’s eligibility to sell mortgages to and service mortgages for Freddie Mac;
- E. WHEREAS**, on August 24, 2009 (the “Petition Date”), the Debtor filed a voluntary petition for relief under chapter 11 of title 11 of the Bankruptcy Code (the “Bankruptcy Code”) in the United States Bankruptcy Court for the Middle District of Florida, Jacksonville Division, (the “Bankruptcy Court”) (the “Chapter 11 Case”). TBW’s wholly-owned subsidiaries, REO Specialists, LLC and Home America Mortgage, Inc., subsequently filed voluntary petitions for relief and were administratively consolidated with the Chapter 11 Case. The Debtor remains in possession of its assets and continues to manage its business as debtor in possession. No trustee or examiner has been appointed in the Chapter 11 Case;
- F. WHEREAS**, on or about September 20, 2009, Freddie Mac and TBW, as Debtor, entered into a written stipulation (the “Freddie Mac Stipulation”) to resolve the issues related to the transfer of servicing of Freddie Mac loans from the Debtor to three interim servicers [Doc. No. 288];
- G. WHEREAS**, the Freddie Mac Stipulation was approved by the Bankruptcy Court by an order entered on September 29, 2009 [Doc. No. 350];
- H. WHEREAS**, Freddie Mac filed its Claim No. 2629 (the “Freddie Mac Claim”) in the amount of \$1,782,255,016.51;
- I. WHEREAS**, on November 12, 2010, the Debtor and the Committee, as Co-Proponents, filed the Second Amended and Restated Joint Plan of Liquidation of the Debtors and

the Official Committee of Unsecured Creditors (the "**Plan**"), along with the Second Amended and Restated Disclosure Statement, which was approved pursuant to the Order Approving Second Amended and Restated Disclosure Statement, Scheduling Confirmation Hearing, and Fixing Time for Filing Acceptances or Rejection of Second Amended and Restated Joint Plan of Liquidation entered on November 23, 2010; [Doc. No. 2190]

**J. WHEREAS**, on or about December 10, 2010, the Debtor filed its Objection to the Freddie Mac Claim; [Doc. No. 2256]

**K. WHEREAS**, the Debtor contends that it has affirmative claims against Freddie Mac, which include: claims based on tax and insurance servicing advances for the benefit of Freddie Mac; claims based on unpaid servicing fees owed to TBW; and claims based on repurchase payments made to Freddie Mac ("**Debtor's Claims**");

**L. WHEREAS**, Freddie Mac disputes the validity of the Debtor's Claims and contends that it has good, viable and complete defenses to the Debtor's Claims and that it has good and substantial bases for the Freddie Mac Claim;

**M. WHEREAS**, the Settling Parties have concluded that because of, among other things, the complexity, inherent delay and substantial expense of litigating the issues between them, the length of time necessary to resolve each of those issues, and the uncertainty involved and the concomitant disruption to the Debtor's effort to generate distributions for the benefit of the Debtor's creditors, it is in their respective best interests to resolve their disputes and related matters on the terms set forth in this Agreement; and,

**N. WHEREAS**, the Debtor further believes that the compromise and settlement provided herein is fair and reasonable, and in the best interests of the Debtor, the Debtor's estate and its creditors.

**NOW, THEREFORE**, the Settling Parties, in consideration of the promises, covenants and agreements herein described and for other good and valuable consideration acknowledged by each of them to be satisfactory and adequate, and intending to be legally bound, do hereby mutually agree as follows, subject to Bankruptcy Court approval:

## **ARTICLE I SETTLEMENT TERMS**

**Section 1.1. Support of Amended Plan.** Freddie Mac agrees that upon approval of this Agreement in accordance with Bankruptcy Rule 9019, it will change its vote prior to or at the hearing on confirmation of the Amended Plan and vote in favor of and affirmatively support the Plan, as amended, to incorporate the terms of this Agreement in a form and substance reasonably satisfactory to Freddie Mac, the Debtor and the Committee (the "**Amended Plan**"). Freddie Mac will not object to confirmation of the Amended Plan and will not support any competing plan relating to the Debtor under the Bankruptcy Code so long as the Debtor and the Committee are diligently prosecuting the Amended Plan.

**Section 1.2. Payment by Freddie Mac.** Freddie Mac shall make available to the Estate the cumulative amount of \$53,492,259.86 as follows:

(a) As of the Settlement Effective Date (defined below), Freddie Mac hereby transfers to the Debtor all of its rights in and to \$53,041,337 on deposit at Regions Bank, plus any interest actually accrued on this amount, as allocated to Freddie Mac in the Debtor's Final Reconciliation Report (the "**Regions Funds**"); and

(b) On the Settlement Effective Date, Freddie Mac shall make available to the Debtor (or the Plan Trust formed pursuant to the Amended Plan) an amount equal to \$450,922.86, less the amount of interest accrued on the Regions Funds, as set forth in Section 1.3 below.

**Section 1.3. Borrower Protocol and Related Funds.** Freddie Mac agrees to continue to perform all obligations as set forth in the Order Establishing Protocol to Resolve Borrower Issues entered by the Bankruptcy Court on February 24, 2010 [Doc. No. 1079] and Paragraph 93 of the Debtor's Final Reconciliation Report (together, the "**Borrower Protocol**"). Not later than three (3) business days after the Settlement Effective Date, the Debtor shall pay to Freddie Mac \$6,121,244.00, which are monies collected, received and/or accounted for by the Debtor that relate to "net-funded" loans to which Freddie Mac took title pursuant to the Borrower Protocol. The Settling Parties agree that \$450,922.86 of the amounts due to Freddie Mac under this paragraph, less the amount of interest accrued on the Regions Funds, will be applied against the amounts due to the Debtor under Section 1.2(b) above, and the remainder shall be paid to Freddie Mac within three (3) business days after the Settlement Effective Date. To the extent that the Debtor or the Plan Trustee collects or receives additional funds relating to net funded loans to which Freddie Mac took title pursuant to the Borrower Protocol, those funds shall be paid to Freddie Mac within five (5) business days of receipt.

**Section 1.4. Sale of Mortgage Servicing Rights.** As of the Settlement Effective Date, the Settling Parties agree that Freddie Mac is the sole and exclusive owner of the mortgage servicing rights related to the Freddie Mac loan portfolio serviced by TBW ("**MSRs**"), and the Debtor releases any and all rights, claims or interests that TBW has or may have had in the MSRs. Notwithstanding the foregoing, Freddie Mac agrees to endeavor to sell the MSRs promptly without assumption by a buyer of selling representations and warranties (i) on an "as-is, where-is" basis provided that a buyer will not be responsible for any origination related representations and warranties, including, but not limited to, compliance issues, (ii) a buyer will not be responsible for any servicing obligations prior to the transfer date, and (iii) free of any other damage claims related to the loans covered by TBW's two Freddie Mac seller/servicer numbers (collectively, the "**Loan Pool**"), respectively, in accordance with the following terms:

(a) The sale shall take place outside the Bankruptcy Court.

(b) Freddie Mac will seek, in good faith, to engage Navigant Capital Advisors, LLC ("**Navigant**") and Milestone Advisors, LLC ("**Milestone**") (collectively, the "**Brokers**"), as co-brokers in connection with such sale, which engagement shall (i) provide for a fee payable to the Brokers in the total aggregate amount of one percent (1%) of the gross sales price of the MSRs and (ii) be on such other terms mutually acceptable to Freddie Mac and the Debtor.

(c) A sale may only take place to a Freddie Mac-approved servicer in good standing, with requisite financial criteria, and other adequate resources necessary to complete the transaction, as determined by Freddie Mac in its sole discretion, exercised in good faith.

(d) The specific terms and conditions of the MSR sale transaction described in this Section 1.4, including pricing and allocation of sales proceeds, are set forth in **Exhibit A** to this Agreement. Because Exhibit A contains competitively sensitive information that could affect the results of the MSR sale transaction, the Settling Parties agree that Exhibit A will be treated as confidential and will not be disclosed to third-parties or filed with the Bankruptcy Court except with the express written consent of the Settling Parties. To the extent that there is a conflict between the provisions of this Section 1.4 and Exhibit A, the provisions of Exhibit A shall control and govern the MSR sale described herein.

(e) In the event that a sale of the MSRs is consummated in accordance with the terms of Exhibit A to this Agreement, the Debtor, Natixis Real Estate Holdings LLC, and Sovereign Bank will receive between \$5,000,000 and \$30,000,000 of the sales proceeds in accordance with the terms in Exhibit A.

(f) In the event that the sales process identified herein does not result in a sale and Freddie Mac later sells the MSRs at any time during the one year after the Settlement Effective Date (hereinafter, a "**Subsequent Sale**") to a Qualifying Bidder, as such term is defined in Exhibit A, in accordance with Exhibit A, then the Debtor shall be entitled to receive the sums due under, and calculated on the basis of, this Section 1.4 (and Exhibit A to this Agreement) as if the Subsequent Sale occurred in accordance with this Agreement.

**Section 1.5. Limited Conflict Waiver.** Freddie Mac is aware that the Brokers identified in Section 1.4(b) above have acted as advisors to other interested parties in the Bankruptcy Case. More specifically:

(a) Freddie Mac acknowledges that Navigant or its employees and representatives have acted and/or may, in the future, act as: (i) management of the Debtor and its subsidiaries, some but not all of which are debtors in possession in the Bankruptcy Case; (ii) Plan Trustee of the Liquidating Trust provided for in the Amended Plan; (iii) support for the roles set forth in (i) and (ii) of this subparagraph; and (iv) a resource for the Committee with respect to financial analysis and other matters in lieu of the Committee's retention of its own financial advisor; and,

(b) Milestone has acted and will continue to act as financial advisor to Sovereign Bank in the Bankruptcy Case.

(c) Except with regard to Ocala (defined below) or any other non-debtor affiliates of the Debtor, Freddie Mac consents to Navigant and Milestone acting and continuing to act in the capacities described in this Section 1.5.

(d) Freddie Mac hereby waives any conflict of interest that may result from Navigant and Milestone acting as Brokers in the MSR sale transaction described in Section 1.4 above, subject to brokerage agreements being entered into between Freddie Mac and Navigant and Milestone. The form of brokerage agreement attached hereto as **Exhibit B** is acceptable to

Freddie Mac and Navigant. Except as set forth in the first sentence of this subparagraph, nothing herein shall be deemed to be a waiver of any conflict of interest arising from any activity or role of Navigant and Milestone with regard to Ocala or any other non-debtor affiliates of the Debtor. For the avoidance of doubt, Freddie Mac agrees that it will not raise the role of Navigant and Milestone acting as Brokers in the MSR sale transaction for any conflict purposes in connection with Ocala or any other non-debtor affiliates of the Debtor.

**Section 1.6. Allocation of Loans to Freddie Mac.** The Debtor and the Committee disclaim any ownership interest in any and all loans held by Freddie Mac and further acknowledge and agree that Freddie Mac is the sole and exclusive owner of the 7,790 loans allocated to Freddie Mac in the Debtor's Final Reconciliation Report filed with the Bankruptcy Court on July 1, 2010 and set forth in **Exhibit C** to this Agreement. Freddie Mac will acknowledge that it has no rights or interest in the 165 loans on Exhibit D to the Debtor's Amended Motion to Approve Debtor's Allocation of Disputed Loans and Related Assets, which were previously identified by Freddie Mac as possible assets belonging to Freddie Mac.

**Section 1.7. Freddie Mac TBW Class 8 General Unsecured Claim.** The Settling Parties agree that Freddie Mac shall have an allowed TBW Class 8 claim under the Amended Plan in an amount equal to \$1,022,000,000 (the "**Allowed Freddie Mac Claim**") in full satisfaction of the Freddie Mac Claim. The Allowed Freddie Mac Claim shall not be entitled to priority or subject to reconsideration, subordination, reduction, offset, or other diminution in amount or classification.

**Section 1.8. Payment to Trade Creditors.** Freddie Mac agrees that the Plan Trustee shall pay over and release to the Liquidating Trust for the exclusive benefit of holders of allowed TBW Class 9 claims under the Amended Plan ("**Trade Creditors**") the first \$6,250,000 to which Freddie Mac would be otherwise entitled under the Amended Plan on account of the Freddie Mac TBW Class 8 claim described in Section 1.7, above (the "**Trade Creditor Participation**"), with all other amounts to which Freddie Mac is entitled under the Amended Plan on account of the Freddie Mac TBW Class 8 claim described in Section 1.7, above, paid to Freddie Mac in accordance with the Amended Plan. Freddie Mac stipulates and agrees that (i) it is not a Trade Creditor and is not entitled to any distribution as a TBW Class 9 claimant and (ii) the Plan Trustee is authorized, as disbursing agent, to distribute the Trade Creditor Participation to Trade Creditors.

**Section 1.9. Plan Amendment.** The Amended Plan shall incorporate the terms of this Agreement and in a form and substance reasonably satisfactory to Freddie Mac, the Debtor and the Committee. A condition precedent to the Effective Date of the Amended Plan shall be receipt by Freddie Mac from the FDIC, as receiver for Colonial Bank, of \$150,257,776 plus accrued interest, if any, on deposit at Colonial Bank, as identified and allocated to Freddie Mac in the Debtor's Final Reconciliation Report. The Settling Parties acknowledge that there may be additional amendments to the Plan, and Freddie Mac agrees that it will not object to any such other amendment so long as that amendment is not inconsistent with the terms of this Agreement, does not adversely affect Freddie Mac's treatment under the Amended Plan, and is in all other respects reasonably satisfactory to Freddie Mac.

## ARTICLE II RELEASES

**Section 2.1. Release of Freddie Mac.** Upon the Settlement Effective Date and subject to Section 2.3, below, the Debtor and the Debtor's estate, on behalf of themselves, each of their respective subsidiaries and affiliates (except as provided in Section 2.3 with respect to Ocala Funding, LLC) and their respective predecessors, successors and assigns, and any other person or entity that claims or might claim through, on behalf of or for the benefit of any of the foregoing, whether directly or derivatively, and the Committee (the "**Estate Releasers**") irrevocably and unconditionally, fully, finally, and forever waive, release, acquit and discharge Freddie Mac, its current and former subsidiaries, affiliates, directors, officers, employees, conservator, receiver, liquidator, trustee, professionals and the predecessors, successors and assigns of any of these (collectively, the "**Freddie Mac Releasees**") from any and all claims, demands, rights, liabilities, or causes of action of any and every kind, character or nature whatsoever, in law or in equity, known or unknown, whether asserted or unasserted, which the Estate Releasers, or any of them, or anyone claiming through them, on their behalf or for their benefit, have or may have or claim to have, now or in the future, against any of the Freddie Mac Releasees that: (i) arise in, relate to or have been or could have been asserted in the Chapter 11 Case or otherwise are based upon, related to, or arise out of or in connection with any of the Debtor's assets or any assets to be received by the Debtor as provided herein; (ii) concern any and all rights, claims or interests that TBW has or may have had in the MSR's; or (iii) are based upon, related to, or arise out of or in connection with any claim, act, fact, transaction, occurrence, statement or omission in connection with, or alleged or that could have been alleged in connection with the relationship between Freddie Mac and TBW, including without limitation, the Debtor's Claims and any other such claim, demand, right, liability, or cause of action for indemnification, contribution, or any other basis in law or equity for damages, costs or fees incurred by the Estate Releasers (collectively, the "**Freddie Mac Released Claims**").

**Section 2.2. Release of the Debtor and the Committee.** Upon the Settlement Effective Date and subject to Section 2.3, below, Freddie Mac, on behalf of itself, its subsidiaries and affiliates, its predecessors, successors and assigns, and any other person or entity that claims or might claim through, on behalf of or for the benefit of any of the foregoing (other than the Federal Housing Finance Agency, which has provided a separate release to the Estate Releasees as of the Effective Date), whether directly or derivatively, irrevocably and unconditionally, fully, finally, and forever waives, releases, acquits and discharges the Debtor, the Debtor's estate, the Debtor's current directors, officers, employees and professionals, the Debtor's subsidiaries and affiliates (except as provided in Section 2.3 with respect to Ocala Funding, LLC), the Committee and the Committee's professionals (collectively, the "**Estate Releasees**") from any and all claims, demands, rights, liabilities, or causes of action of any and every kind, character or nature whatsoever, in law or in equity, known or unknown, whether asserted or unasserted, which Freddie Mac, or anyone claiming through it, on its behalf or for its benefit, has or may have or claim to have, now or in the future, against any Estate Releasee that: (i) are released or deemed to be released pursuant to the Amended Plan; (ii) arise in, relate to or have been or could have been asserted in the Chapter 11 Case or otherwise are based upon, related to, or arise out of or in connection with any of the Debtor's assets or any assets to be received by the Debtor as provided herein; or (iii) are based upon, related to, or arise out of or in connection with any claim, act, fact, transaction, occurrence, statement or omission in connection with, or alleged or that could

have been alleged in connection with the relationship between Freddie Mac and TBW, including without limitation, any such claim, demand, right, liability, or cause of action for indemnification, contribution, or any other basis in law or equity for damages, costs or fees incurred by Freddie Mac (the “**Estate Released Claims**”).

**Section 2.3. Retained Claims and Defenses.** Notwithstanding anything contained in this Agreement to the contrary:

(a) Sections 2.1 and 2.2 are not intended to release, nor shall they have the effect of releasing, any of the Settling Parties from the performance of their obligations in accordance with this Agreement or any other rights, claims or defenses expressly reserved in this Agreement.

(b) Nothing herein is intended to release any claims that any Settling Party may have against any former (i.e., not current) officers, directors, employees, agents, fiduciaries, subsidiaries, accountants, auditors, attorneys, appraisers, joint tortfeasors, or contractors of TBW who or which are not a Settling Party, including without limitation Lee Farkas, Desiree Brown, Paul Allen, Delton DeArmas, Raymond Bowman, or their insurers.

(c) Nothing herein shall be construed to limit, waive or release any claims, demands, rights, causes of action, or defenses that any Settling Party has or may have under the fidelity bonds (“Fidelity Bonds”) or as to any recovery under the Fidelity Bonds that are currently the subject of litigation in an adversary proceeding in the Bankruptcy Court (Adversary No. 10-AP-00243-JAF), or any other insurance coverages or indemnities that might apply. The Settling Parties, as appropriate, reserve any and all of their rights, claims and title to any recovery under the Fidelity Bonds, including disputes concerning any such recovery among the Settling Parties or the Plan Trust (as defined in the Amended Plan), and any other insurance coverages or indemnities that might apply. Nothing herein shall be construed to limit, waive or release any claim that Freddie Mac may have to any recovery under the Fidelity Bonds by the Debtor or the Plan Trust.

(d) Nothing herein shall be construed to limit, waive or release any claims, demands, rights, liabilities or causes of action that Ocala Funding, LLC (“**Ocala**”) may have against Freddie Mac, except for Debtor’s Claims as described in Recital K and Section 1.6 above. Nothing herein or in any other provision of this Agreement is intended or should be construed to limit, waive or release any claims, demands, rights, liabilities or causes of action that Ocala or its creditors (except for the Debtor) may have arising from or relating to transfers of money from Ocala to custodial accounts maintained at Colonial Bank by TBW on behalf of Freddie Mac.

(e) Nothing herein shall be construed to limit, waive or release any claim or defense that Freddie Mac may have against Ocala, its officers, directors, employees, agents, fiduciaries, accountants, auditors, attorneys, appraisers, joint tortfeasors, creditors, or contractors; provided, however, that nothing in this subparagraph shall be construed to limit the release of Debtor and the Debtor’s estate set forth in Section 2.2 of this Agreement, but further provided that the release of Debtor and the Debtor’s estate in Section 2.2 of this Agreement shall not preclude any defense that Freddie Mac may assert in response to any of Ocala’s or any other



non-debtor third-party claims, demands, rights, liabilities or causes of action including without limitation any defenses that may pertain to the Debtor or the Debtor's estate.

(f) Nothing herein or in any other provision of this Agreement is intended or should be construed to limit, waive or release any claims, demands, rights, liabilities or causes of action that Freddie Mac and the Brokers may have under the brokerage agreements that are described in Section 1.4(b) above.

### **ARTICLE III REPRESENTATIONS AND WARRANTIES**

**Section 3.1. Representations and Warranties of the Debtor.** The Debtor hereby represents and warrants that:

(a) it is duly organized and validly existing under the laws of the jurisdiction of its organization with all requisite power and authority to execute and deliver this Agreement and to consummate the transactions contemplated hereby;

(b) subject to any necessary approval by the Bankruptcy Court, it has full requisite power and authority to execute and deliver this Agreement and to perform its obligations under this Agreement, and the execution, delivery and performance hereof, and the instruments and documents required to be executed by it in connection herewith, (i) have been duly and validly authorized by it and (ii) are not in contravention of its organization documents or any agreement specifically applicable to it or to which it is a party;

(c) no proceeding, litigation or adversary proceeding before any court, arbitrator or administrative or governmental body is pending against it which would adversely affect its ability to enter into this Agreement or to perform its obligations hereunder; and

(d) it, and subject to approval by the Bankruptcy Court, has the power and authority to bind itself to the terms of this Agreement or otherwise has been duly authorized to execute and deliver this Agreement on its behalf.

**Section 3.2. Representations and Warranties of Freddie Mac.** Freddie Mac hereby represents and warrants that:

(a) it is duly organized, validly existing and in good standing under the laws of the United States with all requisite power and authority to execute and deliver this Agreement and to consummate the transactions contemplated hereby;

(b) prior to Freddie Mac signing this Agreement, FHFA, as conservator for Freddie Mac, has reviewed and approved this Agreement;

(c) it has full requisite power and authority to execute and deliver and to perform its obligations under this Agreement, and the execution, delivery and performance hereof, and the instruments and documents required to be executed by it in connection herewith (i) have been duly and validly authorized by it and (ii) are not in contravention of its organizational documents or any agreement specifically applicable to it or to which it is a party;

(d) no proceeding, litigation or adversary proceeding before any court, arbitrator or administrative or governmental body is pending against it which would adversely affect its ability to enter into this Agreement or to perform its obligations hereunder; and

(e) it has the power and authority to bind itself to the terms of this Agreement or otherwise has been duly authorized to execute and deliver this Agreement on its behalf.

**Section 3.3. Representations and Warranties of the Committee.** The Committee hereby represents and warrants that:

(a) it is duly organized and validly existing under the provisions of the Bankruptcy Code;

(b) subject to the approval of the Bankruptcy Court, it has full requisite power and authority to execute and deliver and to perform its obligations under this Agreement, and the execution, delivery and performance hereof, and the instruments and documents required to be executed by it in connection herewith (i) have been duly and validly authorized by it and (ii) are not in contravention of its organizational documents or any agreement specifically applicable to it or to which it is a party;

(c) no proceeding, litigation or adversary proceeding before any court, distributor or administrative or governmental body is pending against it which would adversely affect its ability to enter into this Agreement or to perform its obligations hereunder; and

(d) subject to the approval of the Bankruptcy Court, it has the power and authority to bind itself to the terms of this Agreement or otherwise has been duly authorized to execute and deliver this Agreement on its behalf.

**Section 3.4. Additional Representations.** Each Settling Party represents and acknowledges as follows:

(a) In executing this Agreement, it does not rely, and has not relied, upon any representation or statement made by any other party or any of such other party's representative, agents or attorneys with regard to the subject matter, basis or effect of this Agreement or otherwise, other than as may be stated specifically in this Agreement.

(b) In executing this Agreement, it has relied entirely upon its own judgment, beliefs and interest and upon the advice of its counsel and that it has had a reasonable period of time to consider the terms of this Agreement before entering into it.

(c) It has reviewed this Agreement and that it fully understands and voluntarily accepts all of the provisions contained herein.

(d) This Agreement was the product of negotiations among the parties hereto and that any rule of construction as to ambiguities being resolved against the drafting party shall not apply in the interpretation of this Agreement.

#### ARTICLE IV COVENANTS

**Section 4.1. Covenants of the Debtor and its Advisors.** The Debtor hereby covenants and agrees that it will take all actions reasonably necessary to obtain Bankruptcy Court approval of this Agreement prior to or contemporaneously with the commencement of the hearing regarding confirmation of the Amended Plan.

**Section 4.2. Covenants of Freddie Mac.** Freddie Mac hereby covenants and agrees that it will support approval of the Amended Plan, the entry of the Confirmation Order (defined below) or the consummation, implementation and administration of the Amended Plan. Freddie Mac will take any and all actions reasonably necessary to support the Debtor's 9019 Motion seeking approval of this Agreement.

#### ARTICLE V SETTLEMENT EFFECTIVE DATE

**Section 5.1. Settlement Effective Date.** This Agreement shall become effective on the first date on which each of the following has occurred ("**Settlement Effective Date**"):

(a) This Agreement has been approved by the Bankruptcy Court pursuant to an order in a form and substance reasonably satisfactory to Freddie Mac, the Debtor and the Committee;

(b) The Bankruptcy Court's entry of an order confirming the Amended Plan in a form and substance reasonably satisfactory to Freddie Mac, the Debtor, and the Committee and which incorporates the terms of this Agreement in its entirety into the Amended Plan and any other amendments to the Plan; provided, however, that Freddie Mac's approval rights as to the form of the confirmation order shall be limited to the effect of the order on the terms of this Agreement;

(c) The occurrence of the "**Effective Date**" as defined in, and subject to the conditions precedent set forth in, the Amended Plan; and,

(d) Freddie Mac's receipt from the Federal Deposit Insurance Corp., as receiver for Colonial Bank ("**FDIC**"), of \$150,257,776.00 plus accrued interest, if any, on deposit at Colonial Bank, as identified and allocated to Freddie Mac in the Debtor's Final Reconciliation Report.

Consummation of a sale of the MSRs is not, and shall not be, a condition to effectiveness of this Agreement.

**Section 5.2. Termination Date.** If the Settlement Effective Date has not occurred by August 31, 2011, unless such date is extended by a writing signed by all Settling Parties (the "**Termination Date**"), then this Agreement shall terminate and become null and void, subject to and in accordance with Section 5.3 below, and the Settling Parties shall be returned to the status *quo ante* as if this Agreement had never been executed.

**Section 5.3. Effect of Termination.** Unless otherwise ordered by the Bankruptcy Court, in the event that this Agreement terminates as set forth in Section 5.2, then:

(a) to the extent reasonably practicable, the Settling Parties shall be restored to their respective positions as of the date of this Agreement with all of their respective claims and defenses, preserved as they existed on that date;

(b) the Settling Parties shall take such steps and file such documents as are necessary to cause such claims and defenses to be restored;

(c) except for the provisions of this Section 5.3, the terms and provisions of this Agreement shall be null and void and shall have no further force or effect with respect to the Settling Parties, and neither the existence nor the terms of this Agreement (nor any negotiations preceding this Agreement nor any acts performed pursuant to, or in furtherance of, this Agreement) shall be used in any action or proceeding for any purpose; and

(d) any judgment or order entered by the Bankruptcy Court in accordance with the terms of this Agreement shall be treated as vacated, *nunc pro tunc*.

## **ARTICLE VI NO ADMISSIONS**

**Section 6.1. No Admissions.** The Settling Parties intend this Agreement and the settlement described herein to be a final and complete resolution of all disputes between them, including without limitation with respect to this Bankruptcy Case, and it shall not be deemed an admission by any Settling Party as to the merits of any claim or defense with respect to the Debtor's Claims or the Freddie Mac Claim.

**Section 6.2. Agreement Inadmissible.** Neither this Agreement nor the settlement, nor any act performed or document executed pursuant to or in furtherance of this Agreement or the settlement is, or may be deemed to be or may be used as an admission of, or evidence of, any liability, fault or omission of the Settling Parties in any civil, criminal or administrative proceeding in any court, administrative agency or other tribunal. Neither this Agreement nor the settlement, nor any act performed or document executed pursuant to or in furtherance of this Agreement or the settlement shall be admissible in any proceeding for any purpose, except to seek approval of or to enforce the terms of the Agreement.

**Section 6.3. Recitals Not Binding.** In the event that the settlement is terminated or does not receive preliminary or final court approval, the recitals set forth in the agreement shall not constitute binding admissions, statements against interest or be admissible as evidence in any proceedings between or involving one or more of the Settling Parties to establish any fact, waiver, estoppel, contention, assertion or allegation of any kind or nature whatsoever.

## **ARTICLE VII MISCELLANEOUS PROVISIONS**

**Section 7.1. Good Faith.** The Settling Parties agree that the Agreement was negotiated in good faith by the Settling Parties, and reflects a settlement that was reached

voluntarily after consultation with each of the Settling Parties' representative competent legal counsel.

**Section 7.2. Integration.** Any exhibits to this Agreement are material and integral parts hereof and are fully incorporated herein by this reference.

**Section 7.3. Amendments.** This Agreement may be amended or modified only by a written instrument signed by or on behalf of all Settling Parties, as the case may be, or their respective successors-in-interest.

**Section 7.4. Authority.** Each counsel or other person executing this Agreement or any of its exhibits on behalf of any party hereto hereby warrants that such person has the full authority to do so.

**Section 7.5. Counterparts.** This Agreement may be executed by facsimile and in one or more counterparts. All executed counterparts and each of them shall be deemed to be one and the same instrument. Counsel for the parties to this Agreement shall exchange among themselves original signed counterparts and a complete set of executed counterparts shall be filed with the Bankruptcy Court.

**Section 7.6. Successors.** This Agreement shall be binding upon, and inure to the benefit of, the successors of the parties hereto, including any corporation or other entity into or with which any party merges, consolidates or reorganizes.

**Section 7.7. Jurisdiction.** The United States Bankruptcy Court for the Middle District of Florida, Jacksonville Division, shall retain jurisdiction with respect to implementation and enforcement of the terms of this Agreement, and all parties hereto submit to the jurisdiction of such Bankruptcy Court for purposes of implementing and enforcing the settlement embodied in this Agreement. The Settling Parties expressly reserve their jurisdictional rights to any action, suit or proceeding commenced outside the terms of this Agreement.

**Section 7.8. Further Assurances.** Each of the Settling Parties hereto agrees to execute and deliver, or to cause to be executed and delivered, all such instruments, and to take all such action as the other Settling Parties may reasonably request in order to effectuate the intent and purposes of, and to carry out the terms of, this Agreement.

**Section 7.9. Cooperation.** The Debtor and Freddie Mac shall cooperate with each other and share information after the Settlement Effective Date in connection with the implementation of the settlement and compromise described herein, the sale of the MSR's, and Freddie Mac's and the Debtor's attempts to recover insurance proceeds and other indemnities for their losses; provided, however, notwithstanding the foregoing, neither the Debtor nor Freddie Mac shall be required pursuant to the terms of this Agreement to share information in connection with attempts to recover insurance proceeds and other indemnities that either such party determines, in good faith, would be contrary to its best interest to share with the other party. The Debtor and Freddie Mac shall be under no obligation to share information that is privileged or otherwise protected from disclosure under applicable law.

**Section 7.10. Governing Law.** This Agreement shall be governed by and construed in accordance with the laws of the United States. Insofar as there may be no applicable precedent, the laws of Virginia shall be deemed reflective of the laws of the United States.

**Section 7.11. Entire Agreement.** This Agreement integrates the whole of all agreements and understandings of any sort or character between the Settling Parties concerning the subject matter of the Agreement and supersedes all prior negotiations, discussions, or agreements of any sort whatsoever, whether oral or written, concerning the subject matter of the Agreement. Except for the release from the Federal Housing and Finance Agency mentioned in Section 2.2 of this Agreement, there are no representations, agreements, or inducements relating to the subject matter hereof, except as set forth expressly and specifically in this Agreement. There are no unwritten, oral, or verbal understandings, agreements, or representations of any sort whatsoever between the Settling Parties, it being stipulated that the rights of the Settling Parties against one another shall be governed exclusively by this Agreement.




