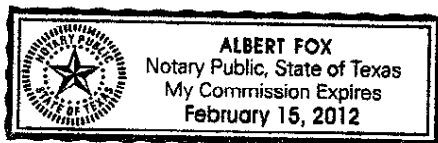

NOTICE OF DEADLINE REQUIRING FILING OF PROOFS OF CLAIM ON OR BEFORE JUNE 15, 2010, AT 5:00 P.M. EASTERN STANDARD TIME TO ALL PERSONS AND ENTITIES WITH CLAIMS AGAINST Taylor, Bean & Whitaker Mortgage Corp., (the "Debtor").
