THIS MATTER came on for consideration without hearing on U.S. Bank National Association, not in its individual capacity, but solely as Trustee with respect to eight residential mortgage-backed securities transactions ("U.S. Bank"), Manufacturers and Traders Trust Co. ("M&T") and Bayview Loan Servicing, LLC's ("Bayview") (collectively the "Movants") *Ex-Parte Motion to Shorten Time for Response to Discovery Requests to Bank of America, National Association* (the "Motion") (DE# 327). ORDERED as follows:
