The Official Committee of Unsecured Creditors (the "Committee"), for and on behalf of the estate of Taylor, Bean & Whitaker Mortgage Corp. (the "Debtor" or "TBW") (the Committee, together with the Debtor or TBW, will be referred to as the "Movant"), pursuant to the *Order Granting Motion for the Official Committee of Unsecured Creditors for Derivative Standing to Prosecute Litigation in the Name of the Debtor* [D.E. # 1020] and the *Notice of Sixth Amendment to the Colorable Actions List filed Pursuant to the Order Granting Motion of the Official Committee of*

*Unsecured Creditors for Derivative Standing to Prosecute Certain Actions in the Name of the Debtor, Adding Claims Against Certain Entities and Individuals* [D.E. # 3272]<sup>1</sup>, along with and pursuant to Federal Rule of Bankruptcy Procedure 3007 and Local Rule 3007-1, hereby files this objection (the “Objection”) to the claims listed on the attached **Exhibit “A”** as follows:
