**SEVENTEENTH OMNIBUS OBJECTION TO CLAIMS**  
(WARN Act Claims, Employee Reimbursement Claims, and Employee Vacation Claims)

**IMPORTANT NOTICE TO CREDITORS:

**If you disagree with the objection or the recommended treatment, you must file a written response WITHIN 30 DAYS from the date of service stated in this objection, explaining why your claim should be allowed as filed, and you must mail a copy to the undersigned attorneys OR YOUR CLAIM MAY BE DISPOSED OF IN ACCORDANCE WITH THE RECOMMENDATION IN THIS OBJECTION.**

**Any written response must contain the case name, case number, and must be filed with the Clerk of the United States Bankruptcy Court, Bryan Simpson United States Courthouse, 300 North Hogan Street, Suite 3-350, Jacksonville, FL 32202 with a copy to Debi Evans Galler, Esq., Berger Singerman, P.A., 200 South Biscayne Blvd., Suite 1000, Miami, FL 33131.**

The Official Committee of Unsecured Creditors (the “Committee”), for and on behalf of the estate of Taylor, Bean & Whitaker Mortgage Corp. (the “Debtor” or “TBW”) (the Committee, together with the Debtor or TBW, will be referred to as the “Movant”), pursuant to the *Order Granting Motion for the Official Committee of Unsecured Creditors for Derivative Standing to Prosecute Litigation in the Name of the Debtor* [D.E. # 1020] and the *Notice of Sixth Amendment to the Colorable Actions List filed Pursuant to the Order Granting Motion of the Official Committee of Unsecured Creditors for Derivative Standing to Prosecute Certain Actions in the Name of the Debtor, Adding Claims Against*

*Certain Entities and Individuals* [D.E. # 3272]<sup>1</sup>, along with and pursuant to Federal Rule of Bankruptcy Procedure 3007 and Local Rule 3007-1, hereby files this objection (the “Objection”) to the claims listed on the attached **Exhibit “A”** as follows:

**Exhibit “A”:** The Movant objects to each claim set forth on Exhibit “A” on the basis that the claim includes employee claims that should be settled pursuant to a mediated agreement in regard to the WARN Act Adversary Proceeding (Case No. 09-00439-JAF), vacation claim amounts inconsistent with the books and records of TBW, and/or reimbursement claim amounts also inconsistent with the books and records of TBW and otherwise improperly classified. To the extent that a claim listed on Exhibit A consists of any claim amount that will be settled pursuant to the WARN Act Settlement, under which said proof of claim for WARN damages will be withdrawn, Movant objects. The WARN Act Settlement was resolved at mediation and a motion to approve the settlement is anticipated to be filed shortly, but the Movant files this Omnibus Objection to all claims on Exhibit A to the extent they consist of claims that will be satisfied through the WARN Act Settlement in an abundance of caution. To the extent that the claims listed on Exhibit A relate to a claim for employee vacation and/or reimbursement, the Movant objects to the claim to the extent that it overstates the vacation and/or reimbursement entitlement or otherwise is inconsistent with the books and records of TBW. Further, to the extent that the claims listed on Exhibit A contain any employee reimbursement component and that seek classification for such reimbursement component as something other than a general unsecured claim in Class 9, the claim should be reclassified as a general unsecured claim in Class 9.

The Exhibit attached hereto lists the claims being objected to by the Movant, with the specific grounds and reasons for the Movant’s objection, and the requested disposition of such claims, as set forth above.

**All claimants that have received this Objection should locate their names and claims on the attached Exhibit, which names are listed alphabetically.**

The Movant reserves the right to amend any objection to any claim set forth on Exhibits “A”, to object on additional grounds not set forth in Exhibit “A”, and/or to object to any further claims not presently set forth on this Exhibit. By filing this Objection, the Movant does not waive the right to file
