The United States of America, by and through its undersigned counsel, Robert E. O'Neill United States Attorney for the Middle District of Florida, responds to the debtor's Objection to Claim of the Department of the Treasury-Internal Revenue Service as follows:

Admits that the debtor is objecting to the Internal Revenue Service's proof of claim.
