**ORDER ON DEBTOR'S OMNIBUS OBJECTION #3:
CLAIMS IMPROPERLY FILED AS SECURED AND/OR
PRIORITY**

THIS CASE came on for consideration upon the Debtor's Omnibus Objection #3: Claims Improperly Filed as Secured and/or Priority (the "**Objection**") [Docket No. 2239]. The Objection was served with negative notice on December 10, 2010. Pursuant to the Objection and Local Rule 2002-4, any objections, responses, or opposition to the Objection were due no later than January 9, 2011. The holders of the Claims listed on the attached Exhibits A and B did not file any objections or responses.

The holders of the claims listed on Exhibit C filed responses (the "**Responses**") to the Objection. In addition to the claims listed on Exhibit C, a response was filed by Jon and Claire Chapman [Dkt. No. 2391]. The Objection and Responses (including the Chapman response) came before the Court at a scheduling conference on June 17, 2011. The Chapmans did not appear at the scheduling conference, and their response indicates that their claim has been satisfied. Accordingly, the Objection will be approved with respect to the Chapman claim. The

Responses listed on Exhibit C have been set for a scheduling conference for August 25, 2011 as indicated in Exhibit C and in the Court's Notice of Scheduling Conference [Dkt. No. 3243].

The holder of the claim listed on Exhibit D lodged an informal response with the Debtor. The claim listed on Exhibit D is excluded from this Order and will be resolved by way of stipulation or other relief as agreed to by the Debtors and such claimant, or as further ordered by this Court.


It appearing that the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, it appearing that proper and adequate notice having been given and no other or further notice is necessary, and the Court having considered the above and being fully advised in the premises, the Court finds that the Objection should be sustained as set forth herein with respect to the claims listed on Exhibits A and B. Accordingly, it is

ORDERED that:

1. The Objection is sustained with respect to the claims listed on the attached Exhibits A and B.
2. The claims set forth on the attached Exhibit A shall be reclassified as indicated therein.
3. The claims set forth on the attached Exhibit B shall be reclassified as indicated therein.

4. Nothing in this Order shall impair or prejudice the rights of the Debtor's to further object to the claims set forth in Exhibit A and B for any reason, such rights to object being expressly preserved by this Order.
