**ORDER ON DEBTOR'S OMNIBUS OBJECTION #6:



The scheduling conference was continued to August 25, 2011 with respect to certain of the Responses as set forth in Exhibit B and as indicated in the Court's Notice of Scheduling Conference [Dkt. No. 3449].

It appearing that the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, it appearing that proper and adequate notice having been given and no other or further notice is necessary, and the Court having considered the above and being fully advised in the premises, the Court finds that the Objection should be sustained as set forth herein with respect to the claims listed on Exhibit A. Accordingly, it is

ORDERED that:

1. The Objection is sustained with respect to the claims listed on the attached Exhibits A.
2. The claims set forth on the attached Exhibit A shall be reclassified as indicated therein.
3. Nothing in this Order shall impair or prejudice the rights of the Debtor's to further object to the claims set forth in Exhibit A for any reason, such rights to object being expressly preserved by this Order.
