NOTICE OF HEARING ON FINAL APPLICATIONS FOR ALLOWANCE

PLEASE TAKE NOTICE that a hearing in these jointly administered cases will be conducted on **Monday, November 14, 2011, at 11:00 a.m.** in Courtroom 4-D, Bryan Simpson United States Courthouse, 300 North Hogan Street, Jacksonville, Florida, before The Honorable Jerry A. Funk, United States Bankruptcy Judge, to consider and act upon the following matters:

6. **Sixth and Final Application of Stichter, Riedel, Blain & Prosser, P.A., as Attorneys for Debtors and Debtors In Possession, for (1) Allowance and Payment of Compensation for Services Rendered and Reimbursement of Expenses Incurred and (2) Final Approval of Awards of Compensation and Reimbursement (seeking sixth allowance of \$175,745.50 in compensation and \$5,133.16 in expenses for the period May 1, 2011, through July 21, 2011, and final allowance of \$1,651,714.50 in aggregate compensation and \$56,595.61 in aggregate expenses for the period August 24, 2009, through July 21, 2011) (Doc. No. 4154)**

and to transact such other business as may properly come before the hearing.

Objections: Pursuant to the *Order Confirming Third Amended and Restated Joint Plan of Liquidation of the Debtors and the Official Committee of Unsecured Creditors* (Doc. No. 3420), any objections to the final allowance of compensation or reimbursement of expenses to Professionals must be filed and served on counsel for the Plan Trustee (as listed below) on or before **November 7, 2011**.

Appropriate Attire: Local Rule 5072-1(b)(16) requires that all persons appearing in court should dress in business attire consistent with their financial abilities. Among other things, a coat and tie are appropriate for a man, and a dress or pants suit is appropriate for a woman.

Avoid Delays at Courthouse Security Checkpoints: Local Rule 5073-1 restricts the entry of cellular telephones and computers into the courthouse except with a specific order of authorization issued beforehand by the presiding judge. Due to heightened security procedures, every person must present photo identification to enter the courthouse.
