ORDER SUSTAINING TWENTY-SEVENTH OMNIBUS OBJECTION TO CLAIMS

THIS MATTER came before the Court without a hearing, upon the *Twenty-Seventh Omnibus Objection to Claims* [D.E. 3543] (the “Twenty-Seventh Omnibus Objection”) dated August 9, 2011, filed by the Official Committee of Unsecured Creditors (the “Committee”) under negative notice in accordance with Local Rules 2002-4 and 3007-1, on behalf of the Debtor, Taylor, Bean & Whitaker Mortgage Corp., now the Taylor, Bean & Whitaker Plan Trust (the Committee, together with the Debtor and the Plan Trust, will be referred to as the “Objector”¹). The Objector represents that:

¹ As of the effective date of the *Third Amended and Restated Joint Plan of Liquidation of the Debtors and the Official Committee of Unsecured Creditors* [D.E. 3240], August 10, 2011, the Debtors and the Committee have been replaced by the Taylor, Bean & Whitaker Plan Trust. The Trust and its Trustee, Neil F. Luria, are substituted in as the objecting party in this matter for the Objector.

1. The Twenty-Seventh Omnibus Objection was served on August 9, 2011 upon all interested parties identified on the exhibits to the Twenty-Seventh Omnibus Objection.

2. The Twenty-Seventh Omnibus Objection provided all claimants the right and opportunity to file a response to the objection no later than 30 days from the date of service of the objection. Accordingly, the deadline for responses to the Twenty-Seventh Omnibus Objection was September 8, 2011.

3. The Objector asserted in the Twenty-Seventh Omnibus Objection that the claimants who filed individual proofs of claim for WARN Act damages were also members of the WARN Act Class approved by this Court in that certain adversary proceeding captioned *Nicholas A. Callahan, Julie Whiteaker, Eric E. Anderson, Chris Escandon, Charles Van Hartsell III, Debra Orlando, Dezi Teiann Jessop, William P. Hickey III and Tanjanika Carter, on behalf of themselves and all others similarly situated v. Taylor Bean & Whitaker Mortgage Corp.*, (Adv. Pro. No. 09-00439-JAF) and would be paid their WARN Act damages in a separate WARN Act Settlement Agreement and not through the claims administration and payment process. The Motion to approve the WARN Act Settlement Agreement was filed on October 7, 2011 [D.E. 4143], and approved by the Court at a hearing on December 2, 2011.


4. As of December 6, 2011, counsel for the Plan Trustee has not received any responses and a check of the electronic entries docketed in this case confirms that no responses have been filed with respect to the Twenty-Seventh Omnibus Objection.

The Court, having considered the Twenty-Seventh Omnibus Objection, noting the non-response by the claimants identified on Exhibit "A" to the Twenty-Seventh Omnibus Objection, and being otherwise fully advised in the premises, thereupon

ORDERS as follows:

1. The Twenty-Seventh Omnibus Objection is hereby sustained with respect to claims listed on Exhibit "A" to this Order on the basis that such claimants failed to timely respond to the Twenty-Seventh Omnibus Objection by September 8, 2011, and on the basis that each claimant is receiving a distribution under the Court approved the WARN Act Settlement. Claims listed on Exhibit "A" are hereby stricken and disallowed in their entirety.
