**AGREED ORDER RESOLVING OBJECTION TO CLAIM OF LYNN HANSEN**


This case is before the Court on the *Objection to Claim of Lynn Hansen* (the "Objection") filed on August 9, 2011 [D.E. 3529] by the Official Committee of Unsecured Creditors, for and on behalf of the estate of Taylor, Bean & Whitaker Mortgage Corp. (the "Debtor" or "TBW"), the above-captioned debtor, with respect to Claim No. 3353 filed on March 16, 2011, which amends Claim No. 3252 (collectively, the "Hansen Claim"), on behalf of the bankruptcy estate (the "Hansen Estate") of Lynn Hansen ("Hansen"). Debora A. Casey (the "Trustee") of the Hansen Estate filed a response to the Objection (the "Response") [D.E. 5128]. At a hearing held on June 8, 2012, counsel announced on the record the agreement of the Trustee and the Plan Trustee for the Taylor, Bean & Whitaker Plan Trust to the entry of an agreed order to be submitted by the parties. On the basis of

the consent of the parties, it is

ORDERED:

1. Conditioned upon the entry of the *Agreed Order Granting Motion by Chapter 7 Trustee of Lynn Hansen for Entry of Order Granting Relief From the Stay* (the "Agreed Order") granting the *Motion by Chapter 7 Trustee of Lynn Hansen for Entry of Order Granting Relief from the Automatic Stay* [D.E. 5149], the Objection is SUSTAINED.
2. Conditioned upon the entry of the Agreed Order, the Trustee waives the Hansen Claim in full and will not seek to enforce any judgment obtained or settlement reached against TBW's estate. Accordingly, Claim Nos. 3353 and 3252 are disallowed.
3. Any reinstatement of the Hansen Claim or additional claims asserted by the Trustee against the Debtor's estate shall be subject to the provisions of the Agreed Order.
