**UNCONTESTED MOTION TO CONTINUE FINAL  
EVIDENTIARY HEARING SCHEDULED FOR NOVEMBER 1, 2012**

National Union Fire Insurance Company of Pittsburgh, Pa., Chartis Specialty Insurance Company, Granite State Insurance Company, The Insurance Company of the State of Pennsylvania, Commerce and Industry Insurance Company, and certain other affiliates of Chartis Inc. (collectively the "Claimants"), by their undersigned attorneys, hereby move the Court to continue the Final Evidentiary Hearing on their Application for Payment of Administrative Expense Claim [DE 4026], now scheduled for November 1, 2012 at 1:30 p.m. The basis for this uncontested motion is that the parties are involved in ongoing settlement discussions relating to not only to the Application and also to other open issues and potential claims. A global settlement would mean that the Court would not be required to resolve the issues raised in the contested Application for Payment.
