RESPONSE TO DEBTOR'S OBJECTION TO CLAIM NO. 3284 AND 3488 FILED BY BANK
OF INTERNET [DOCKET NO. 5687]

Now comes Bank of Internet and hereby responds to the Objection of the Taylor Bean & Whitaker Plan Trust to claims number 3284 and 3488 and hereby responds as follows:

Bank of Internet initially filed a proof of claim [Claim No. 3284] in the amount of \$960,460.46. The grounds for the claim were that monies were held in an account by Taylor Bean and Whitaker Mortgage Corp. for funds held in trust. The monies were properly payable to Bank of Internet. Subsequent to the filing of the proof of claim [Claim No. 3284], Bank of Internet received funds from the FDIC for Colonial Bank, the bank at which the funds were on deposit. The payment reduced the claim to Bank of Internet to \$28,780.54, which is claim number 3488.

Bank of Internet received an additional \$10,585.63. Pursuant to Bank of Internet's records, an additional \$18,194.91 is still due and owing. A copy of Bank of Internet's records itemizing the payments still due and owing is attached hereto as Exhibit "A". For the foregoing reasons, Bank of Internet requests that the Objection to Claim No. 3284 and 3488 be sustained in part and overruled in part. Bank of Internet requests an unsecured claim in the amount of \$18,194.91.
