SIXTY FIFTH OMNIBUS OBJECTION TO CLAIMS
(Borrower Claims are Fully Satisfied)

**IMPORTANT NOTICE TO CREDITOR:
THIS IS AN OBJECTION TO YOUR CLAIM**

This objection seeks to disallow your claim. Please read this objection carefully to identify which claim/scheduled claim is objected to and what disposition is recommended for your claim.

If you disagree with the objection or the recommended treatment, you must file a written response WITHIN 30 DAYS from February 12, 2013, explaining why your claim should be allowed as presently filed, and you must mail a copy to the undersigned attorneys OR YOUR CLAIM MAY BE DISPOSED OF IN ACCORDANCE WITH THE RECOMMENDATION IN THIS OBJECTION.

Any written response must include the following: (i) the approved case caption and the title of the objection to which the response is directed; (ii) the name of the claimant and the official claim number; (iii) a description of the basis for the amount of its underlying proof of claim or scheduled claim; (iv) a concise statement setting forth the reasons why the Court should not sustain the objection, including, but not limited to, the specific factual and legal bases upon which the claimant will reply in opposing the objection; and (v) address, telephone and/or email contact information for the claimant.

Any written response must be filed with the Clerk of the United States Bankruptcy Court, Bryan Simpson United States Courthouse, 300 North Hogan Street, Suite 3-350, Jacksonville, FL 32202 with a copy to Alisa Paige Mason, Esq., Berger Singerman LLP, 1450 Brickell Avenue, Suite 1900, Miami, FL 33131-3453.

Neil F. Luria, as Plan Trustee (“Plan Trustee”) for the Taylor, Bean & Whitaker Plan Trust¹ (the “Plan Trust”) on behalf of the Debtor, Taylor, Bean & Whitaker Mortgage Corp. (“TBW”), by and through undersigned counsel, and pursuant to Federal Rule of Bankruptcy Procedure 3007 and Local Rules 3007-1 and 2002-4, hereby files this omnibus objection (the “Omnibus Objection”) to the claims listed on **Exhibit “A”** (collectively, the “Claims”). The Plan Trustee seeks to disallow the Claims for the following reason:

Exhibit A: Claims have been Satisfied in Full. The Plan Trustee objects to the Claims listed on Exhibit A on the basis that checks have been mailed to the respective claimants to satisfy each of the Claims pursuant to the *Order Approving Settlement Agreement, as Amended, by and among Taylor, Bean & Whitaker Mortgage Corp., the Federal Deposit Insurance Corporation, as Receiver of Colonial Bank, and the Official Committee of Unsecured Creditors* (the “FDIC Settlement Order”) [D.E. 1936]. Section 1.7(d) (“BB&T Funds”) of the settlement agreement by and among TBW, the Official Committee of Unsecured Creditors and the FDIC-R, as approved by the FDIC Settlement Order, provides that payments will be made to borrowers harmed by TBW and Colonial Bank in order to address certain borrower issues described in detail in (1) the *Final Reconciliation Report of Debtor Taylor, Bean & Whitaker Mortgage Corp.* [D.E. 1644] and (2) the *Motion of Debtor Taylor, Bean & Whitaker Mortgage Corp., for Approval of Protocol to Resolve Borrower Issues* [D.E. 927], which was approved by the Court on February 24, 2010 [Order, D.E. 1079]. The Plan Trustee recommends disallowing each of the Claims in their entirety on the basis that the Claims have been satisfied.

The Plan Trustee requests that the Claims be treated as noted above, and believes that these Claims should be disallowed in accordance with the Bankruptcy Code.

All Claimants that have received this Omnibus Objection should locate their name(s) and Claim(s) on the attached Exhibit “A” which lists the Claimants alphabetically.

¹ As of the effective date of the *Third Amended and Restated Joint Plan of Liquidation of the Debtors and the Official Committee of Unsecured Creditors* [D.E. 3240] (the “Plan”), August 10, 2011, the Debtors and the Official Committee of Unsecured Creditors have been replaced, in most part and according to the terms of the Plan, by the Taylor, Bean & Whitaker Plan Trust (the “Plan Trust”).

The Plan Trustee reserves the right to amend his objection to any claims set forth herein, to object on additional grounds not set forth herein and/or to object to any further claims not presently set forth herein. By filing this Omnibus Objection, the Plan Trustee does not waive the right to file further objections or to pursue avoidance actions or other causes of action.

WHEREFORE, the Plan Trustee respectfully requests that the Court (1) treat the Claims set forth herein, as recommended by the Plan Trustee, without prejudice to the rights of the Plan Trustee or other interested parties to file further objections or to pursue avoidance actions or other causes of action, and (2) grant such other and further relief as is just and appropriate.
