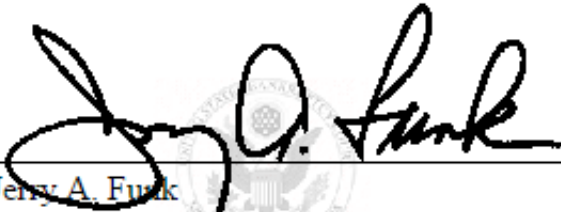

**ORDER SUSTAINING OBJECTION TO CLAIM NUMBER 165  
 FILED BY LANDAMERICA ONESTOP, INC.**

THIS CASE is before the Court for consideration of the *Plan Trustee's Objection to Claim Number 165 Filed by LandAmerica Onestop, Inc.* [ECF No. 8279] (the "Objection") dated August 31, 2015, filed by Neil F. Luria as Plan Trustee (the "Plan Trustee") for the Taylor, Bean & Whitaker Plan Trust, under negative notice in accordance with Local Rules 2002-4 and 3007-

1. Upon review of the record and representation of the Plan Trustee, the Court finds as follows:

1. The Objection was served on August 31, 2015 upon LandAmerica OneStop, Inc. (the "Claimant") as indicated on the Objection.

2. The Objection provided the Claimant the right and opportunity to file a response to the Objection no later than 30 days from August 31, 2015, plus an additional three days for service. Accordingly, the deadline to file a response to the Objection was October 5, 2015.

3. As of October 8, 2015, a review of the electronic entries docketed in this case confirms that no response to the Objection has been filed with the Court.

The Court, having considered the Objection, and being otherwise fully advised in the premises, thereupon

**ORDERS** as follows:

1. The Objection is hereby SUSTAINED.
2. Claim No. 165 is stricken as a claim in the bankruptcy estate of Debtor, Taylor Bean & Whitaker Mortgage Corp. (Case No. 3:09-bk-7047-JAF) and is transferred to the bankruptcy estate of the Debtor, REO Specialists, LLC (Case No. 3:09-bk-10022-JAF).
3. The Court retains jurisdiction with respect to all matters arising from or related to the implementation or interpretation of this Order.
