**ORDER GRANTING FIFTH QUARTERLY INTERIM APPLICATION OF
BLANK ROME COMISKY & MCCAULEY LLP FOR COMPENSATION FOR
SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES
AS COUNSEL TO THE STATUTORY COMMITTEE OF UNSECURED
CREDITORS OF TRANS WORLD AIRLINES, INC., ET AL. FOR THE
QUARTERLY PERIOD FROM JANUARY 1, 2002 THROUGH MARCH 31, 2002**

Upon consideration of the Fifth Quarterly Interim Application (the "Fifth Quarterly Fee Application") of Blank Rome Comisky & McCauley LLP for Compensation for Services Rendered and Reimbursement of Expenses as Counsel to the Statutory Committee of Unsecured Creditors (the "Committee") of Trans World Airlines, Inc., et al. (the "Debtors") for the Quarterly Period From January 1, 2002 through March 31, 2002 (the "Fifth Quarterly Application Period"), and adequate notice of the Fifth Quarterly Fee Application having been given and it appearing that no other notice need be given, and this Court having jurisdiction over the Fifth Quarterly Fee Application, and after any proceedings in respect of this matter, and sufficient cause appearing thereof, it is ORDERED that:

1. The Fifth Quarterly Fee Application is approved.
2. BRCM is allowed interim compensation for professional services during the Fifth Quarterly Application Period in the amount of \$153,468.00, and reimbursement of expenses during the Fifth Quarterly Application Period in the amount of \$9,890.63.

3. The Debtors are authorized and directed to pay the outstanding balance owed to BRCM for the above approved fees and expenses.
