PLEASE TAKE FURTHER NOTICE that a hearing on the Fee Application shall be held only in the event timely objections are filed and the parties are unable to reach a resolution of such objections. In the absence of any objection or responsive pleading to the Fee Application, BRCM may file a Certificate of No Objection with the Court after which the Debtors are authorized to pay BRCM an amount equal to 80% of the fees (\$18,486.00), and 100% of the expenses (\$667.75) requested in the Fee Application. If an objection to the Fee Application is

timely filed and served, the Debtors shall be authorized to pay BRCM 80% of the fees and 100% of the expenses not subject to the objection.
