**RENEWED CERTIFICATION OF NO OBJECTION TO TWELFTH AND
THIRTEENTH MONTHLY APPLICATIONS OF TRAUB, BONACQUIST & FOX LLP
FOR COMPENSATION FOR SERVICES RENDERED AND REIMBURSEMENT OF
EXPENSES AS COUNSEL TO THE OFFICIAL COMMITTEE OF RETIREES FOR
THE PERIODS FEBRUARY 1, 2002 THROUGH MARCH 31, 2002, INCLUSIVE
[DOCKET NOS. 3017 & 3173]**

1. On March 20, 2002, Traub, Bonacquist & Fox LLP (“TB&F”), in its capacity as counsel to the Official Committee of Retirees (the “Retirees’ Committee”) of Trans World Airlines, Inc., *et al.*, debtors and debtors-in-possession (the “Debtors”) filed and served its Twelfth Monthly Application of Traub, Bonacquist & Fox LLP, for Compensation for Services Rendered and Reimbursement of Expenses as Counsel to the Official Committee of Retirees for the Period February 1, 2002 through February 28, 2002, Inclusive (the “February Fee Application”) [Docket No. 3017].

2. On April 16, 2002, Traub, Bonacquist & Fox LLP (“TB&F”), in its capacity as counsel to the Official Committee of Retirees (the “Retirees’ Committee”) of Trans

World Airlines, Inc., *et al.*, debtors and debtors-in-possession (the “Debtors”) filed and served its Thirteenth Monthly Application of Traub, Bonacquist & Fox LLP, for Compensation for Services Rendered and Reimbursement of Expenses as Counsel to the Official Committee of Retirees for the Period March 1, 2002 through March 31, 2002, Inclusive (the “March Fee Application”) [Docket No. 3173].

3. A Notice of Applications (the “Notices”) and the Applications were served upon the Debtors, Debtors’ counsels, counsel to the Debtors’ post-petition lender, counsel to the Official Committee of Unsecured Creditors, counsel to any other statutory committee appointed by the Office of the United States Trustee, and the United States Trustee.

4. The notices provided that any objections or responses to the Applications were to be filed with the Court and served on the undersigned counsel no later than 20 days after the filing and service of the Applications.

5. On March 28, 2002, M BNA America Bank, N.A. (“MBNA”) filed an objection to administrative payments including the TB&F February Fee Application [Docket No. 3045].

6. On April 22, 2002, MBNA filed an objection to payment, *inter alia*, the TB&F March Fee Application [Docket No. 3179].

7. On April 11, 2002, the U.S. Trustee filed an objection to the TB&F February Fee Application [Docket No. 3107].

8. MBNA and the U.S. Trustee have agreed to withdraw their objections to the TB&F February and March Fee Applications conditioned upon payment of such fees and expenses shall be subject to disgorgement to the extent that the Court determines that disgorgement is appropriate. A copy of the Stipulation and Agreed Order Resolving Objection of MBNA America Bank, N.A. to Applications of Traub, Bonacquist & Fox LLP for Allowance of

Compensation and Reimbursement of Expenses Commencing February 1, 2002 and Pertaining to the U.S. Trustee's Objection to TB&F's Third Quarterly Fee Application is attached hereto.

9. Therefore, TB&F is authorized to request from the Debtors payment of 80% of fees for February and March 2002 in the amount of \$23,295.60, and 100% of expenses for February and March 2002 in the amount of \$1,825.35.
