**WITHDRAWAL OF OBJECTIONS TO CONFIRMATION OF DEBTORS' AMENDED
JOINT LIQUIDATING PLAN OF REORGANIZATION BY AIR JAMAICA, LTD., AIR
TRANSPORT ASSOCIATION OF AMERICA, INC.,
BAHAMASAIR HOLDINGS LTD., AND UNIVERSAL AIR TRAVEL PLAN, INC.**

On or about March 7, 2002 Air Jamaica, Ltd., Air Transport Association of America, Inc., Bahamasair Holdings Ltd., and Universal Air Travel Plan, Inc. (collectively the "Withdrawing Objectors"), together with certain other Airlines Clearing House, Inc. ("ACH") participants, filed Objections to Confirmation of Debtors' Amended Joint Liquidating Plan of Reorganization. (Such Objections are hereinafter referred to as "ACH Participant Objections.") As described in the Debtors' Motion for an Order Authorizing Settlements By and Among the Debtors and Various Clearinghouse Participants Pursuant to Rule 9019 of Bankruptcy Procedure and Limiting Notice Thereof, filed on or about May 20, 2002 (the "Clearinghouse Settlement Motion"), each Withdrawing Objector has entered into a "Clearinghouse Settlement" (as defined in the Clearinghouse Settlement Motion) with the Debtors.

Pursuant to the terms of its respective Clearinghouse Settlement with the Debtors, each Withdrawing Objector, through its undersigned counsel, hereby conditionally withdraws its

ACH Participant Objection, reserving the right to renew and reassert such ACH Participant Objection if (a) its Clearinghouse Settlement with the Debtors is not approved in a final order of this Court, or (b) such Clearinghouse Settlement terminates by reason of the failure of any of the conditions set forth therein.
