Basis for Secured Claim. As set forth in the Subject Mineral Liens, the basis for this Proof of Claim includes X-Chem's performance of labor and services and furnishing of equipment, materials and machinery and/or the incurring of expenses for same in connection with the operations performed by the Debtors on various oil and gas wells and associated oil and gas leases. Due to the voluminous nature of the records which comprise the Subject Mineral Liens, those records are not provided herein. Such records will be furnished upon written request to Phil F. Snow, Snow Fogel Spence LLP, 2929 Allen Parkway, Suite 4100, Houston, Texas 77019, counsel for X-Chem.

The total amount of X-Chem's secured claim against Debtors as set forth above is \$181,298.65, exclusive of contractual interest and attorneys' fees.

Prepetition Interest. X-Chem's Standard Terms and Conditions on its Work Order which governs the materials and services furnished by X-Chem along with the subject invoices requires payment in full within thirty (30) days from the date of the invoice. Further, the Terms and Conditions provide for contractual interest at the rate of 1.5% per month on all invoices which are not timely paid in full. X-Chem is entitled to recover prepetition contractual interest.

Post-Petition Interest and Attorney's Fees. X-Chem has incurred and is entitled to recover post-petition interest, legal fees and expenses related to the claims of X-Chem against the Debtors. *See* 11 U.S.C. §§ 502, 506. X-Chem reserves the right to amend this Proof of Claim to include such additional amounts as and when occurred related to X-Chem's claims against the Debtors.

Reclamation Claim. On June 7, 2010, X-Chem filed a Notice of Reclamation Demand and sent a Reclamation Demand Letter informing the Debtors that it furnished certain products and equipment on credit within 45 days before the date of the commencement of this Bankruptcy Case filed May 21, 2010. To the extent the furnished products and equipment are returned, or an Administrative Claim is paid and approved by the Court, X-Chem will amend this claim as appropriate.

Reservation of Rights. The execution and filing of this Proof of Claim is (a) without waiver or release of any of X-Chem's rights, claims, actions, defenses, setoffs or counter-claims against the Debtors or against any other entity or person liable for all or part of the claims or rights of X-Chem under applicable law, (b) not a consent by X-Chem to the subject matter jurisdiction of the Bankruptcy Court with respect to any proceeding commenced before or after the Petition Date by or

against or otherwise involving X-Chem or the claims or rights of X-Chem set forth herein, (c) without waiver of the right to withdraw the reference with respect to the subject matter of the claims or rights of X-Chem set forth herein, any objection or other proceeding commenced with respect thereto or any other proceeding commenced in this bankruptcy case against or otherwise involving X-Chem, (d) without waiver of, without prejudice to, and with full reservation of X-Chem's rights to a jury trial or arbitration with respect to the subject matter of the claims or rights of X-Chem set forth herein, and (e) not an election of remedy which waives or otherwise affects any other remedy available to X-Chem.

X-Chem expressly reserves all rights including, without limitation, its rights (a) to amend, modify or supplement in any respect this Proof of Claim, including any exhibits, schedule or annex, or to file an amended proof of claim for the purpose of modifying or liquidating the amount of any interest, fees, costs and expenses accrued or incurred subsequent to the Petition Date or any contingent or unliquidated claims or rights of X-Chem set forth herein, (b) to file additional proofs of claim, and (c) against third parties.
