Response No 1 – Amount of claim as of date case filed

The exact amount due to Ms Kinkaid is unknown to her at this time. Upon information and belief, there is an unknown amount of back royalties due to her for oil and gas production from a parcel of land in which Ms Kinkaid has a fifty percent (50%) interest in the oil and gas rights and/or royalties more accurately described in the Agreement dated the 22nd day of November, 1887, a copy of which is attached hereto. Ms Kinkaid is uncertain as to the successors in title or status of the property described in this Agreement and is uncertain as to the status of the oil and gas or production of the same from the property. Upon information and belief, two (2) nephews of Ms Kinkaid, Robert W Kinkaid, Jr and Scott Kinkaid, evenly split the other fifty percent (50%) interest in the oil and gas rights and/or royalties in the parcel described in the above-referenced Agreement. Robert W Kinkaid, Jr resides at 213 Yucca Terrace, Plainview, TX 79072 and Scott Kinkaid resides at 13005 Jason Crest Trail, Dallas, TX 75243. All of the production records and any other records that would confirm the amount of back royalties due to Ms Kinkaid are under the exclusive control of the debtor. The failure of the debtor and its predecessors to provide any such production records and other available records to Ms Kinkaid has resulted in the total amount due being unknown to Ms Kinkaid and not capable of calculation by her. +
