Dear Richard,

Enclosed you will find the following documents as it relates to the above

- 1 A term promissory note in the amount of \$30,000 beginning November 1, 2000 payable to Dorothy Basile from Triad Energy Corp Of Wva, Inc
- 2 An amortization schedule of the same \$30,000 note beginning November 1, 2000 and fully amortized at October 1, 2005
- 3 An Assignment and Bill of Sale of Oil and Gas Wells and Leases that covers all the properties in question

Also, pursuant to our conversations we agreed that there would be a development schedule as it relates to these assets so that the overriding royalty interest that you have retained will be economic We hereby acknowledge that it was agreed that by December 31, 2000 we will put in production the Myers #1A well and two of the wells located on what you and I refer to as the Connolly leases In addition, we agreed that by June 30, 2001 we would have in production the B F Hawkins, J T A. Hawkins, and the Asher wells for the mutual benefit of both parties The failure to do either of the two projects above would result in a \$500 a month penalty payable to Dorothy Basile from the commitment date until said wells are put in production. This commitment was agreed on by yourself and I to be subject force majeure as it relates to the mechanical integrity of the wells or governmental regulation preventing us from completing either project
