**ADDENDUM TO PROOF OF CLAIM**

2     Indebtedness Existing as of Petition Date   As of December 31, 2008 (the “Petition Date” ), the Debtors were indebted to the Agent and Prepetition Lenders in the aggregate amount of ***at least \$70,827,535.05*** which consists of (a) unpaid principal in the aggregate amount of at least \$69,970,000 00, (b) accrued but unpaid interest in the aggregate amount of at least \$818,077 54, (c) prepetition charges, fees, costs and expenses totaling at least \$39,457 51, and (d) for any and all other fees, expenses, costs, additional accrued interest,

Additionally, the Debtors are indebted to the Agent and Prepetition Lenders for any and all amounts due and owing pursuant to the terms of that certain Second Amended and Restated Debtor in Possession Financing Amendment to Credit Agreement dated April 2, 2009 by and among Triad Energy Corporation, Triad Resources, Inc., and Triad Oil & Gas Co. Ltd., as Borrowers, the Agent, and Prepetition Lenders. The Agent and Prepetition Lenders additionally claim the benefit of (a) all adequate protection security interests, liens, mortgages, and other rights and protections granted to them or received by them from and after the Petition Date by operation of law, orders of this Court, or otherwise, (b) all

renewals, extensions, ratifications, supplements, amendments, corrections, and other prior or subsequent documentation evidencing or relating to the claims of the Agent and Prepetition Lenders, and (c) any other filed or recorded documents.
