**ORDER AUTHORIZING REJECTION OF SIXTH SET OF ASSORTED  
EXECUTORY CONTRACTS AND PERSONAL PROPERTY LEASES**

On July 7, 2005, the Court considered the Sixth Motion to Authorize Rejections of Assorted Executory Contracts and Personal Property Leases and Brief in Support [Docket No. 1392] (the "Motion")<sup>1</sup> filed by the above-referenced debtors and debtors in possession (the "Debtors"). The Court finds that the Debtors have exercised sound business judgment to determine that the Contracts, a summary of which is attached hereto as **Exhibit A**, should be rejected. The Court further finds that adequate notice of this Motion has been given and no other notice needs to be given. Therefore, it is

**ORDERED** that the Motion is **GRANTED**. It is further

**ORDERED** that the Contracts shall be rejected effective as of June 14, 2005, and, unless the Debtors and the respective counterparties agree otherwise, the respective counterparties to the Contracts shall retrieve any property relating to the Contracts within a reasonable time (with the cost of such retrieval to be borne by such counterparties). It is further

**ORDERED** that to the extent that a counterparty to a Contract refuses to timely retrieve personal property relating to the Contract, the Debtors are authorized to dispose of such property by any reasonable means and shall have a claim against such counterparty for the costs of such disposition.
