Based on the status conference held on July 7, 2005, on the debtors' first amended motion to determine the Verizon entities' ability to effectuate setoff (doc. no. 1440),

**IT IS ORDERED** that the first amended motion to determine the Verizon entities' ability to effectuate setoff (doc. no. 1440) shall be converted to an adversary proceeding. The Clerk of Court shall open an adversary proceeding file and assign an adversary proceeding number, and the adversary proceeding will be styled VarTec Telecom, Inc., et al., v. Verizon Communications, Inc. The file shall include the first amended motion to determine the Verizon entities' ability to effectuate setoff
