**LIMITED OBJECTION OF 770 "L" STREET TO DEBTORS' SALE MOTION**  
**TO THE HONORABLE HARLIN D. HALE, CHIEF BANKRUPTCY JUDGE:**

770 "L" Street Investment Group ("Landlord") hereby files this limited objection to the Debtors' Motion for Authority to Sell Assets Free and Clear of All Liens, Claims, Rights, Interests, and Encumbrances and for Related Relief (Substantially All of the Debtors' Remaining Assets) (the "Sale Motion"):

1. Landlord is the landlord for the Debtors' premises located at 770 "L" Street, Suite 100A, Sacramento, California (the "Premises"). As of the petition date of November 1, 2004, the Debtors were current on the rent due under the lease. Landlord filed a proof of claim on or about December 22, 2004 against the tenant under the lease, debtor Telco Network Services, Inc. (Case No. 04-81702), against guarantor Var Tec Telecom, Inc. (Case No. 04-81694) and guarantor

Excel Telecommunications, Inc. (Case No. 04-81698). True and correct copies of the first two pages of each proof of claim are attached hereto as Exhibit 1.<sup>1</sup>

2. According to the Sale Motion, the Debtors “do not request authority to assume executory contracts and unexpired leases and assign the same to buyer.” Sale Motion, ¶21. The Sale Motion describes that the buyer approved by the Court shall designate in writing to the Debtors which executory contracts and unexpired leases that the buyer desires to have assumed by the Debtors and assigned to the buyer. The Debtors thereafter are obligated to file a motion to assume and assign the executory contracts and unexpired leases identified in the designation by the buyer and the Debtors are required to use reasonable efforts to obtain the approval of such a motion. Sale Motion ¶¶ 21-22.

3. Landlord hereby files this limited objection to preserve, to the extent necessary, all of its rights to object to the assumption and/or assignment of the lease for the Premises under section 365 of the Bankruptcy Code. At this time, the rent due under the lease is paid current. However, other charges, including attorneys’ fees and operating expenses, chargeable to the Debtors under the lease and the guarantees must be paid in full under section 365 as a condition to any assumption and assignment. In addition, given that the identity and financial condition of the buyer are unknown at this time because the winning bidder under the sale procedures has not been identified, Landlord reserves all rights to require adequate assurance of future performance under the lease as is required under section 365 as a condition to assumption and/or assignment of the lease.

4. This limited objection is also filed without prejudice to Landlord’s rights in the event the Debtors do not remain current on the rent and other obligations due under the lease.


