**FOURTH ORDER GRANTING EXTENSION OF EXCLUSIVE PERIODS DURING  
WHICH DEBTORS MAY FILE AND SOLICIT ACCEPTANCES OF A PLAN**

On July 22, 2005, the Court considered the Motion to Further Extend for Sixty Days the Exclusive Periods During Which Debtors May File and Solicit Acceptances of a Plan and Report Pursuant to Local Bankruptcy Rule 3016.1 [Docket No. 1471] (the "Motion")<sup>1</sup> filed by the above-referenced debtors and debtors in possession (the "Debtors"). The Court finds that cause exists to increase the Exclusive Periods, as provided herein. The Court further finds that adequate notice of this Motion has been given and no other notice needs to be given. Therefore, it is

**ORDERED** that the Motion is **GRANTED** as provided herein. It is further

**ORDERED** that the Debtors' exclusive period for filing a plan shall be and hereby is extended through and including September 7, 2005. It is further

**ORDERED** that the Debtors' exclusive period to solicit acceptance of such plan shall be and hereby is extended through and including November 7, 2005. It is further

**ORDERED** that this Order is without prejudice to the Debtors' right to seek further extensions of such Exclusive Periods.
