Connie Mitchell, Joe Cook, and Miller Williams, requiring them to produce the documents listed

on the Exhibit A attached to the Motion no later than seven days after the entry of this Order;

IT IS FURTHER ORDERED, that the Committee is authorized to serve subpoenas

upon Ronald Hughes, Hollis Ray Atkinson, Gary Egger, Kevin McAleer, Sonia Ayers,

Connie Mitchell, Joe Cook, and Miller Williams, requiring them to appear for examination

regarding the acts, conduct, property, liabilities, and financial affairs of the Debtors on or before

the dates set forth in the Motion; and

IT IS FURTHER ORDERED, that this Order does not prejudice or limit either the

Objectors' right to seek to preclude or limit depositions that the Committee may seek to take of

the Objectors in any future proceeding in which the Committee asserts claims against the

Objectors, or the Committee's right to oppose any such request by the Objectors.
