# ORDER GRANTING MOTION TO ENTER INTO CONTRACT WITH FISERV SOLUTIONS, INC. (D/B/A PERSONIX)

On August 18, 2005, the Court considered the Motion to Enter Into Contract with Fiserve Solutions, Inc. (d/b/a Personix) [Docket No. 1477] (the "Motion")<sup>1</sup> filed by the above-referenced debtors and debtors in possession (the "Debtors").
