ORDERED that the Debtors' exclusive period for filing a plan shall be and hereby
is extended through and including October 7, 2005. It is further

ORDERED that the Debtors' exclusive period to solicit acceptance of such plan shall be and hereby is extended through and including December 9, 2005. It is further

ORDERED that this Order is without prejudice to the Debtors' right to seek further extensions of such Exclusive Periods.
