**MOTION FOR SETTING AND  
REQUEST FOR EXPEDITED HEARING**

1. The above-referenced debtors and debtors in possession (collectively, the "Debtors")<sup>1</sup> request that a hearing be set on the Motion to Approve Statement of Work for Fraud Management Services Offered by Communications Management Services, Inc. (the "Motion")<sup>2</sup> for **October 18, 2005, at 1:30 p.m.** An expedited hearing on the Motion is necessary to effectuate the execution of the Statement of Work dated October 10, 2005 by and between VarTec Telecom, Inc. and Communications Management Services, Inc. ("CMS"). On or before the proposed hearing date, the Debtors expect to terminate certain employees that currently provide the services to be provided by CMS. Although those employees are expected to be hired by CMS, to ensure continuity, the Debtors need the Agreement to be approved as soon as possible.
2. Notice of the proposed expedited hearing and the Motion will be provided as follows: (a) by electronic service through the Court's ECF service in compliance
