### SECOND ORDER AUTHORIZING REJECTION OF CIRCUIT AGREEMENTS

On August 18, 2005, the Court considered the Motion to Authorize Rejection of Circuit Agreements [Docket No. 1395] (the "Motion")<sup>1</sup> filed by the above-referenced debtors and debtors in possession (the "Debtors"). The Court finds that the Debtors have exercised sound business judgment to determine that the Agreements as provided herein, should be rejected. The Court further finds that adequate notice of this Motion has been given and no other notice needs to be given. Therefore, it is

ORDERED that the Motion is GRANTED as set forth below. It is further

**ORDERED** that the Motion as to the Agreements set forth on **Exhibit A** is hereby abated and the Agreements are disconnected as set forth in the *Stipulation and Order* for Assumption and Assignment of Executory Contracts, and Related Cure, Among (I) the Debtor, (II) BellSouth Telecommunications, Inc., and (III) Comtel Telecom Assets LP, and Settlement of Adversary Proceeding No. 05-3233 [Exhibit A to Docket No. 1700] (the "Stipulation"). The Stipulation was approved by the Court on August 15, 2005. It is further

**ORDERED** that the Agreements set forth in **Exhibit B** (the "MCI Agreements") are deemed disconnected in accordance with their terms. No further charges are due by the Debtors to MCI Network Services, Inc. f/k/a MCI WorldCom Network Services, Inc. and MCI Communications Services, Inc. f/k/a MCI WorldCom Communications, Inc. (collectively "MCI") after the Disconnection Date set forth on **Exhibit B** for each respective MCI Agreement. MCI and the Debtors reserve all of their rights and legal positions regarding the claims arising prior to the Disconnection Date for each respective MCI Agreement set forth on **Exhibit B**. Nothing contained herein shall preclude MCI or the Debtors from taking future positions as to other agreements, excluding the MCI Agreements, that is inconsistent with the relief granted herein. It is further

**ORDERED** that the Agreement set forth in <u>Exhibit C</u> (the "Sprint Agreement") is deemed rejected as of the Disconnection Date set forth on <u>Exhibit C</u>. Sprint Communications Company L.P. ("Sprint") and the Debtors reserve all of their rights and legal positions regarding the claims arising prior to the Disconnect Date set forth on <u>Exhibit C</u>. Nothing contained herein shall preclude Sprint or the Debtors from taking

future positions as to other agreements, excluding the Sprint Agreement, that is inconsistent with the relief granted herein. It is further

**ORDERED** that the Agreements set forth on <u>**Exhibit D**</u> (the "WilTel Agreements") are deemed rejected as of the Disconnection Date set forth on <u>**Exhibit D**</u>. WilTel Communications, L.L.C. f/k/a Williams Communications, L.L.C. ("WilTel") agrees to waive any and all claims, prepetition and postpetition, related to the WilTel Agreements. Nothing contained herein shall preclude WilTel or the Debtors from taking future positions as to other agreements, excluding the WilTel Agreements, that is inconsistent with the relief granted herein. It is further

**ORDERED** that the Agreements set forth on <u>Exhibit E</u> (the "Broadwing Agreements") are deemed disconnected in accordance with their terms as of the Disconnection Date set forth on <u>Exhibit E</u>. Broadwing Communications Services, Inc. d/b/a IXC Communications Services, Inc. ("Broadwing") agrees to waive any and all claims, prepetition and postpetition, related to the Broadwing Agreements as set forth on <u>Exhibit E</u> only. Nothing contained herein shall preclude Broadwing or the Debtors from taking future positions as to other agreements, excluding the Broadwing Agreements, that is inconsistent with the relief granted herein.
