NOTICE OF FILING OF IR SCHEDULE

On November 17, 2005, the above-referenced debtors and debtors in possession (collectively, the "Debtors")¹ filed their Motion to Approve Settlement of Claims of Excel's Independent Representatives and Procedures relating Thereto [Docket No. 2070] (the "Motion") in which they seek approval of, among other things, a comprehensive compromise and settlement (the "Global IR Settlement") of all claims held by independent representatives of Excel Telecommunications, Inc. and Excel Communications Marketing, Inc. who were active as of November 1, 2004, according to the business records of the Debtors.

On November 23, 2005, the Court entered its Order Approving Procedures and Notices relating to Settlement of Claims Held by Excel's Independent Representatives [Docket No. 2111] (the "IR Settlement Procedures Order") in which it approved, among other things, certain notice and service procedures relating to the Global IR Settlement and the subsequent filing of the IR Schedule (as defined in the Motion).

Scouler Andrews, L.L.C., the claims expert for the Official Committee of Excel Independent Representatives, has verified the accuracy of the IR Schedule, and as required under the IR Settlement Procedures, the Debtors hereby file the IR Schedule, which is attached hereto as **Exhibit A**.
