# ORDER REGARDING DEBTORS' CLAIMS OBJECTION NUMBER 7 OBJECTION TO CERTAIN TAX CLAIMS (SUBSTANTIVE OBJECTIONS)

On December 13, 2005, the Court considered the Claims Objection Number 7 Objection to Certain Tax Claims (Substantive Objections) [Docket No. 2065] (the "Objection") filed by the above-referenced debtors (the "Debtors"). The Court **FINDS** that (i) proper and sufficient notice of the Objection has been provided and that no further notice is necessary; (ii) it has jurisdiction over the matters raised in the Objection pursuant to 28 U.S.C. §§ 157 and 1334; and (iii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2).
