# ORDER REGARDING DEBTORS' CLAIMS OBJECTION NUMBER 6 OBJECTION TO CERTAIN TAX CLAIMS (DUPLICATE AND LATE FILED PROOFS OF CLAIMS)

On December 19, 2005, the Court considered the Claims Objection Number 6 Objection to Certain Tax Claims (Duplicate and Late Filed Proofs of Claims) [Docket No. 2064] (the "Objection")<sup>1</sup> filed by the above-referenced debtors (the "Debtors"). The Court **FINDS** that (i) proper and sufficient notice of the Objection has been provided and that no further notice is necessary; (ii) it has jurisdiction over the matters raised in the Objection pursuant to 28 U.S.C. §§ 157 and 1334; and (iii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2).
