NINTH ORDER GRANTING EXTENSION OF EXCLUSIVE PERIODS DURING WHICH DEBTORS MAY FILE AND SOLICIT ACCEPTANCES OF A PLAN

On January 3, 2006, the Court considered the Motion to Further Extend for Ninety Days the Exclusive Periods During Which Debtors May File, and Solicit Acceptances of, a Plan and Report Pursuant to Local Bankruptcy Rule 3016.1 [Docket No. 2247] (the "Motion")¹ filed by the above-referenced debtors and debtors in possession (the "Debtors"). Based on, among other things, the Motion and the arguments of counsel, the Court finds that cause exists to increase the Exclusive

Periods, as provided herein. The Court further finds that adequate notice of this Motion has been given and no other notice needs to be given. Therefore, it is

ORDERED that the Motion is **GRANTED** as provided herein. It is further

ORDERED that the Debtors' exclusive period for filing a plan shall be and hereby is extended through and including April 4, 2006 unless shortened by an Order of this Court after the timely filing of an objection and a hearing as set forth below. It is further

ORDERED that the Debtors' exclusive period to solicit acceptance of such plan shall be and hereby is extended through and including June 5, 2006 unless shortened by an Order of this Court after the timely filing of an objection and a hearing as set forth below. It is further

ORDERED that this Order is without prejudice to (i) the Debtors' right to seek further extensions of such Exclusive Periods and (ii) any rights or remedies which the Official Committee may otherwise be entitled to assert. It is further

ORDERED that any party in interest may object to the extensions provided herein by filing a written objection with the Clerk of this Court on or before January 18, 2006 at 5:00 p.m., Central time (the "Objection Deadline"). It is further

ORDERED that if no objection is timely filed and served on or before the Objection Deadline, this Order shall be deemed final as determined from the date of entry hereof. It is further

ORDERED that if an objection is timely filed and served on or before the Objection Deadline, the Court will consider such objection at the hearing currently scheduled for January 23, 2006 at 1:30 p.m.
