ATTACHMENT TO PROOF OF CLAIM OF DOLLAR FINANCIAL GROUP, INC. AGAINST WE THE PEOPLE, LLC

Dollar Financial Group, Inc. (the "Claimant") is the holder of claims (collectively, the "Claims") as set forth herein against We The People LLC (the "Debtor"), the debtor and debtor in possession in Case No. 10-10504 (the "Chapter 11 Case"), which was commenced on or about February 19, 2010 (the "Petition Date") by the Debtors' filing of a voluntary petition for protection under chapter 11 of title 11, United States Code (11 U.S.C. §§ 101, et seq.) (the "Bankruptcy Code") with the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court").

A. <u>Materials Evidencing the Claims</u>.

Claimant is in possession of certain additional materials that may further evidence the Claims, but which have not been attached hereto because they are voluminous and/or include confidential information which Claimant intends to disclose only pursuant to an appropriate confidentiality agreement or protective order of the Bankruptcy Court. Claimant reserves its right to supplement and/or prove up the Claims, or respond to any objections thereto, with additional materials.

B. Summary of the Claims.

The following constitutes a summary of the Claims:

1. <u>Intercompany Claims</u>

Prior to the Petition Date, the Claimant provided the Debtor with funds, facilities and services related to the conduct of the Debtor's business and the acquisition of certain assets, on account of all of which Claimant is owed an amount in excess of \$938,970.

2. Guaranteed obligations

Prior to the Petition Date, Claimant guaranteed certain of Debtor's obligations under certain leases of non-residential real property. To the extent that Claimant becomes obligated to satisfy any obligations of Claimant under such leases or any other obligation for which the Debtor is primarily obligated, Claimant will be subrogated to such claims against the Debtors on account of such obligations, and asserts a contingent and unliquidated claim therefor. In the event that such claims become fixed or liquidated in the future, Claimant reserves the right to amend or supplement its Proof of Claim.

3. Other Contractual Rights and Claims.

Claimant asserts any and all other rights and remedies arising as a matter of law or equity or pursuant to any contract between Claimant and Debtor whether or not such contract is specifically identified herein.

C. Amendment of Claims.

The Claims are subject to adjustment, upward or downward, and amendment for a variety of reasons, including, without limitation, as a result of future events, the discovery and analysis of additional information, the correction of any errors, changes in foreign currency exchange rates (if applicable), the resolution of disputes, the resolution of governmental investigations (whether or not the Debtor and/or its affiliates is/are involved in the investigation), the resolution of lawsuits (whether or not the Debtor and/or its affiliates is/are named parties to the lawsuit) and the assertion of any rights of setoff, netting and/or recoupment. The Claims include any and all contingent and unliquidated claims of Claimant arising under any of the transactions, agreements, facts, or circumstances set forth or referenced herein, and Claimant reserves the right to amend this Proof of Claim accordingly and to set forth its Claims with more particularity as Claimant obtains more information.

D. Interest, Costs and Attorneys' Fees.

Claimant reserves the right to claim prepetition and postpetition interest, costs and attorneys' fees with respect to all of the Claims to the maximum extent permitted by law.

E. Right to Determination in Other Forums.

Claimant reserves all rights to have the Claims and any defenses, counterclaims, or objections thereto determined before a jury, by arbitration, or before any other judicial or administrative body having jurisdiction, and, to the extent necessary to preserve such rights, makes demand therefore. Claimant submits itself to the jurisdiction of the district court and, solely to the extent the Bankruptcy Court may constitutionally exercise the powers of the district court, of the Bankruptcy Court solely for the purpose of the allowance of the Claims. Claimant objects to the exercise of jurisdiction by the district court or the Bankruptcy Court over Claimant or its property for any other purpose.

F. Claim Status and Rights of Setoff

The Claims are asserted as general unsecured claims, provided, however, that if and to the extent that Claimant is otherwise obligated to Debtor or its estate in any amount, Claimant reserves and asserts all rights of setoff to which it may be entitled under applicable law and asserts the Claims as secured claims to the extent of such rights of setoff.

G. Administrative Claim Status.

This Proof of Claim is without prejudice to Claimant's right to assert that some or all of the amounts set forth herein are entitled to be treated as administrative claims against the Debtor pursuant to sections 503(b) and 507(a)(l) of the Bankruptcy Code. This Proof of Claim is in addition to, and is asserted with a full reservation of rights regarding, Claimant's superpriority administrative expense claims against the Debtor pursuant to that certain debtor-in-possession financing facility approved by the Court in the Chapter 11 Case.

H. Reservation of Rights.

To the extent the Claims asserted herein may be asserted against any other debtor-affiliates of the Debtor (collectively, the "Debtors") (in addition to the Debtor referenced herein) under law or equity, including, but not limited to substantive consolidation of the Debtors, this Proof of Claim constitutes a claim against each of the Debtors in the cases, now or at any time in the future, jointly administered under Case No. 10-10503. Additionally, any common law indemnity claims against the Debtor(s) arising in respect of the transactions described herein or described in any amendment hereof are expressly preserved. Claimant also reserves the right to assert additional claims against the Debtor. Neither the filing of this Proof of Claim nor the making of the allegations contained herein, constitute or shall be construed to effect a waiver by the Claimant or any of its affiliates of any rights, claims, causes of action, offsets, setoffs, netting or defenses (or remedies with respect thereto) that Claimant or any of its affiliates may have against or with respect to any person or entity, including, without limitation, against the Debtors or non-debtor affiliates of the Debtors.
