




We are very pleased that you have requested this firm to represent you with respect to certain intellectual property matters. It is our understanding that we will be responsible solely for those matters which have been expressly delegated to us, namely, new matters you authorize and previous files transferred to us from another firm. This letter sets forth the terms of our financial arrangement as to all such matters, whether past, present or future.

LEGAL FEES AND COSTS

Our charges are comprised of professional fees and out-of-pocket costs, which are paid on your behalf. Professional fees are charged by attorneys, including partners and associates, and by non-attorney professionals, including patent agents, patent engineers and paralegals. Out-of-pocket costs may include filing fees, draftsmen fees, photocopies, postage, messenger services, computer research time, foreign associate attorneys, etc.

Our professional fees are based on the amount of time we spend conferring with you, whether in person or by telephone, and attending to your legal matters. Although some matters are billed at a fixed fee, regardless of the time incurred, most fees are calculated at the regular hourly billing rate of the attorney or non-attorney professional performing the work. The hourly rate of each professional is determined by his/her experience, however, in general, the range of billing rates is as follows: paralegals \$65-\$140, patent agents and engineers \$115-\$245, associates \$195-\$300, and partners \$300-\$530. Our fixed fees and hourly rates are subject to change without notice, but are usually adjusted once per year.

We will endeavor to represent you in a cost-effective manner while still maintaining our high standards of quality legal work, prompt and courteous service, and professional decorum. Usually, this means that, subject to your instructions, the responsible partner will determine the overall strategy for a given case, and then closely supervise an associate or non-attorney professional in the implementation of that strategy. The following individuals will most likely be responsible for the majority of your legal matters:

As needed, however, other attorneys and non-attorney professionals in the firm may be involved with your matters and may confer among themselves about your matters in order to permit your work to be efficiently handled at the lowest possible billing rate. Of course, you are free at any time to request that a specific individual handle some or all of your legal matters.

BILLING PRACTICES

Whenever requested, we will provide you with an estimate of our fees and costs for a particular matter. Because of unpredictable circumstances and complications, it is often difficult to estimate the exact cost of legal services.

It is our standard practice to request an advance payment or "retainer" when initiating representation of a new client. Future retainers may also be required for special matters such as foreign filings and litigation. All retainers will be placed in a trust fund and applied to your account as our fees and costs are invoiced. Our invoices are mailed monthly, and any unpaid balance is due and payable within thirty (30) days of their receipt. On any amounts not paid within thirty (30) days of the date of the invoice, a late charge of ten percent (10%) per annum will be assessed. If your bills remain unpaid beyond sixty (60) days, you hereby authorize us to withdraw from your representation.

REPRESENTATION OF BIOTECHNOLOGY CLIENTS

Knobbe, Martens, Olson & Bear, LLP represents a number of clients in the field of biotechnology, some of whom file patent applications containing large numbers of nucleic acid or protein sequences. By executing this retainer agreement, you agree that Knobbe, Martens, Olson & Bear, LLP has no duty to and will not routinely electronically compare the sequences filed by its biotechnology clients to ascertain identity, similarity, or overlap therebetween.

By executing this retainer agreement, you acknowledge the possibility of identical, similar or overlapping sequences being filed for different clients, you consent to the procedures set forth above, and you waive any claim against Knobbe, Martens, Olson & Bear, LLP that such actions breach any duties of loyalty or confidentiality owed to you. We encourage you to seek independent counsel regarding the import of the above procedures.

NOTICE REGARDING CHANGES

Because it is important that we be able to contact you at all times in order to consult with you regarding your intellectual property matters, we require that you inform us, in writing, of any changes in the name, address, telephone number, state of incorporation or other relevant changes regarding you or your business. Whenever we need your instructions or authorization in order to proceed with legal work on your behalf, we will contact you at the latest business address we have received from you. If we cannot reach you at that address, we cannot properly represent you, and you hereby authorize us to withdraw as your attorneys and to permit your application to become abandoned.

SECURITY INTEREST

As security for payment of our professional fees and out-of-pocket costs, you hereby grant us a lien on your intellectual property which is the subject of our representation, on any recoveries from litigation involving such intellectual property and on any other proceeds of such intellectual property. Our lien is for the outstanding sums owed to us during and at the conclusion of the performance of our services. In connection with this lien, you hereby appoint us as your attorneys-in-fact with full authority to execute any documents necessary to perfect our lien.

LEGAL ADVICE

As you may expect, it is very difficult to predict the outcome of legal matters. Therefore, nothing in this Agreement and nothing in our statements to you should be construed as a promise or guarantee as to the outcome of your intellectual property matters. Our comments about such should be construed only as expressions of our professional judgment.

In particular, in filing a patent or trademark application, there is no guarantee that the application will be allowed so that a patent will issue or that a registration will result. The corresponding cost estimate for filing a patent or trademark application does not include the later expense of prosecuting or issuing the applications, nor for maintaining any resulting patent or registration.

PROFESSIONAL LIABILITY INSURANCE

Knobbe, Martens, Olson & Bear, LLP maintains errors and omissions insurance, on all its attorneys, for services rendered in the field of intellectual property.

TERMINATION OF RELATIONSHIP

The attorney-client relationship is one of mutual trust, confidence and respect. Thus, you retain the right to discharge us as your counsel at any time for any reason. ARBITRATION





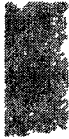
