4. First Omnibus Objection of Debtors and Debtors in Possession to Duplicative Proofs of Claim and Amended Proofs of Claim [D.I. # 439]
 - a. **Status:** No responses. An agreed order will be uploaded in advance of the hearing.

5. Motion of Debtors and Debtors in Possession, Pursuant to Sections 105(a) and 365 of the Bankruptcy Code and Bankruptcy Rule 6006, for Entry of an Order Authorizing Them to Reject an Unexpired Real Property Lease for Property in Middlefield, Ohio [D.I. # 480]
 - a. **Status:** No objection.
