
**ORDER APPROVING EMERGENCY MOTION FOR EXPEDITED HEARING ON
EMERGENCY MOTION FOR RELIEF FROM STAY AND SHORTENING NOTICE OF
HEARING**

This matter coming before the Court on the Motion of Ford Motor Company ("Ford"), seeking entry of an order granting an expedited hearing and shortening the notice of hearing period and time to object on Ford's Emergency Motion for Relief From Stay; the Court having reviewed the Motion; the Court finding that: (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (c) notice of the Expedited Hearing Motion has been provided to: (i) the Debtor; (ii) the United States Trustee, (iii) counsel for the Committee, and (iv) any other party requesting notice of papers filed in this case; (d) notice sufficient under the circumstances has been provided to interested parties and no other or further notice need be provided; (e) capitalized terms not otherwise defined herein have the meanings given to them in the Expedited Hearing Motion; and (f) the legal and factual bases set forth in the Expedited Hearing Motion are sufficient to establish just cause for the relief granted herein;

IT IS, THEREFORE, ORDERED THAT:

1. An Expedited ^{Preliminary} Hearing is hereby scheduled for October 19, 2006 at 1:00 ~~am~~ pm for the court to consider Ford's Emergency Motion for Relief From Stay.
2. The required Notice of Hearing period is hereby shortened.
