- · Work to resolve open tooling issues and secure payment for outstanding tooling dollars
- · Work on various debt collection activities providing historical perspective and documentation in an effort to resolve these issues

- Support the plants with regarding to ongoing production activities and provide a normal communication link between CEP Products and their customers
- Provide CEP Products upper management with Key Account Contact information for individuals at their major accounts whose involvement is critical in resolving Bankruptcy related issues

Because of CEP Products record keeping problems, without Fabnet's involvement the debtors would be flying blind with regard to resolution of many of these A/R and production issues.
