**ORDER, PURSUANT TO SECTION 363(b) OF THE
BANKRUPTCY CODE AND BANKRUPTCY RULE 9019,
APPROVING AND AUTHORIZING THE DEBTORS TO ENTER INTO
A SETTLEMENT AGREEMENT WITH THE UNITED STEEL, PAPER
AND FORESTRY, RUBBER, MANUFACTURING, ENERGY, ALLIED
INDUSTRIAL AND SERVICE EMPLOYEES INTERNATIONAL UNION
REGARDING THE RESOLUTION OF THE DEBTORS' OUTSTANDING
OBLIGATIONS UNDER COLLECTIVE BARGAINING AGREEMENTS**

¹ The Debtors are: CEP Holdings, LLC, Creative Engineered Polymer Products, LLC and Thermoplastics Acquisition, LLC.

Upon the motion (the “**Motion**”)² of CEP Holdings, LLC and its affiliated debtors and debtors-in-possession (each a “**Debtor**” and collectively, the “**Debtors**” or “**CEP**”) in the above-captioned Chapter 11 cases (the “**Cases**”), for entry of an order, pursuant to section 363(b) of the Bankruptcy Code and Bankruptcy Rule 9019, approving the Settlement Agreement, by and between the Debtors and the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Employees International Union f/k/a United Steelworkers of America (the “**Union**”); Mildred Freeman having agreed to participate in the Settlement Agreement before July 24, 2007; the Court having reviewed the Motion and having heard the statements of counsel in support of the relief requested therein at a hearing before the Court (the “**Hearing**”); and the Court having found and concluded that (i) it has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (ii) this is a core proceeding, (iii) notice of the Motion was sufficient under the circumstances, (iv) the approval of the Settlement Agreement is in the best interest of the Debtors’ estates and a business purpose exists for the relief granted herein, and (v) the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein; and this Court having determined that granting the relief requested in the Motion is in the best interests of the Debtors, their estates and their creditors; and after due deliberation and sufficient cause appearing therefore;

IT IS HEREBY ORDERED THAT:

1. The Motion is GRANTED in its entirety.
2. The Settlement Agreement attached hereto as **Exhibit 1** is approved in all respects.

² Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Motion.

3. The Debtors are authorized and empowered to take such steps and perform such acts as may be necessary to implement and effectuate the terms of the Settlement Agreement.

4. Once the payments contemplated in Section 1 of the Settlement Agreement have been made, (a) the Collective Bargaining Agreements shall be deemed terminated and (b) the Union Claims, the King Claim and the Freeman Claim shall be deemed to be resolved in their entirety.

5. Nothing in the Motion or this Order, nor the Debtors' payment of claims pursuant to this Order, shall be deemed or construed as: (a) an admission as to the validity of any claim against the Debtors, including, without limitation, the Union Claims, the King Claim or the Freeman Claim; or (b) a promise to pay any claim, including, without limitation, the Union Claims, the King Claim or the Freeman Claim, provided, however, that the Debtors have agreed to pay the Union Claims, the King Claim and the Freeman Claim up to the amounts set forth in the Settlement Agreement if the Settlement Agreement becomes effective.

6. This Court shall retain jurisdiction to hear and determine all matters arising from or relating to the implementation of this Order, the Settlement Agreement and any disputes arising under the Settlement Agreement.

7. Notwithstanding the possible applicability of Bankruptcy Rules 6004(h), 7062, 9014 or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry.

SETTLEMENT AGREEMENT

FINAL
EFFECTS BARGAINING AGREEMENT

This Agreement sets forth the terms of the settlement entered into between Creative Engineered Polymer Products, LLC (the “Debtor”) and United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Employees International Union (hereinafter referred to as “Union”), with respect to the employees represented by the Union in the bargaining units at the Debtor’s plants located in Crestline, Ohio and Canton, Ohio (the “Facilities”).

WHEREAS, on September 20, 2006 (the “Petition Date”), the Debtor filed a voluntary petition for relief under Chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the Northern District of Ohio Eastern Division (the “Bankruptcy Court”), jointly administered under case number 06-51848.

WHEREAS, as of the date of this Agreement, the Debtor is a party to the following collective bargaining agreements for the benefit of bargaining unit employees at the Facilities: (a) the Collective Bargaining Agreement between Carlisle and the United Steelworkers of America AFL-CIO, CLC on behalf of its Local 3610-04, effective January 1, 2005 through March 31, 2009 (the “Canton CBA”); and (b) the Collective Bargaining Agreement between Carlisle and the United Steelworkers of America AFL-CIO, CLC on behalf of its Local 563-L, effective February 25, 2004 through March 31, 2006 (the “Crestline CBA” and, together with the Canton CBA, the “Collective Bargaining Agreements”). The Crestline CBA was extended by mutual agreement and does not expire until March 31, 2009.

WHEREAS, as of the date of this Agreement, the Debtor maintains the following defined benefit pension plans for the benefit of bargaining unit employees at the Facilities: (a) the Pension Plan for Bargaining Unit Employees of Canton, Ohio Plant of Geauga Company Division of Carlisle Corporation (the “Canton Pension Plan”) and (b) the Pension Plan for Bargaining Unit Employees of Carlisle Engineered Products-Crestline (the “Crestline Pension Plan” and, together with the Canton Pension Plan, the “Pension Plans”).

WHEREAS, production at the Facilities has ceased entirely, the Facilities have been closed and the Debtor has liquidated all or nearly all of their assets in the course of its Chapter 11 case.

WHEREAS, the Union, as the exclusive representative of the bargaining unit employees formerly employed at the Facilities, has asserted the following claims against the Debtor’s estate: (a) an unliquidated unsecured claim for (i) any and all unpaid wages and benefits due to the employees represented by the Union, (ii) unpaid medical benefits on behalf of the employees represented by the Union and their dependents, (iii) contributions and related obligations due to the defined benefit pension plans and the 401(k) plan sponsored by the Debtor that cover individuals represented by the Union; (iv) unpaid and future health plan continuation coverage for individuals represented by the Union; (v) any and all unresolved grievances; and (vi) any union dues or similar

obligations that were withheld from employees' wages but not remitted to the Union (Claim No. 626) (the "Unpaid Benefits Claim"); and (b) an unliquidated unsecured claim for damages resulting from the Debtor's failure to provide proper notice of either the plant closing or mass layoff of its production facilities located in Canton, Ohio and Crestline, Ohio (Claim No. 627) (the "Notice Claim" and, together with the Unpaid Benefits Claim, the "Union Claims").

WHEREAS, the following employees represented by the Union have filed claims against the Debtor and/or CEP Holdings, LLC: (a) Mildred Freeman (Claim No. 587) (the "Freeman Claim"); and (b) Cora King (Claim No. 391) (the "King Claim").

WHEREAS, in order to resolve the Union Claims, the King Claim and the Debtor's remaining obligations under the Collective Bargaining Agreements, the Debtor and the Union have met, bargained in good faith and reached agreement concerning the effect of the decision to close the Facilities and the subject matters related to said plants' closings, which agreement is set forth below;

Now, therefore, for good and sufficient consideration, the receipt and adequacy of which is acknowledged, the parties hereto mutually agree as follows.

AGREEMENT

(1) Payment to Employees: Except as otherwise provided herein, the employees listed on Attachment 1 (the "Employees") will receive a one time payment of \$1,000.00 from the Debtor within 15 business days of the approval of this Agreement by the Bankruptcy Court to settle any and all claims that arise out of the terms of the Collective Bargaining Agreements or are related to the Unpaid Benefits Claim, the Notice Claim and the King Claim. The Union agrees that such payment will satisfy the Union Claims in full and will withdraw the Union Claims when such payments are made. The Union is currently unable to verify that the following Canton plant employees represented by the Union terminated prior the date of the notice of the closing of the Canton plant: Tijah Baskerville, Brooke Ewing, Judy Garcia, Jennifer Grey, Cheryl Kimble, Liz Shasteen and Jeffrey Warrick. The Debtor agrees to pay any such employee the \$1,000 payment provided herein if it is later determined that he or she did not terminate prior to the date of the notice of plant closing. The Union further represents that such payment will satisfy the King Claim in full and that the King Claim will be withdrawn, and the Union further acknowledges that no payment will be made by the Debtor pursuant to this Agreement to Cora King until the Cora Claim has been formally withdrawn. The Debtor and the Union disagree as to whether any amount is owed for or on account of the Union Claims and this payment is being made by the Debtor only as consideration for the Union entering into this Agreement.

(2) Group Health Insurance: For bargaining unit employees and their covered dependents: The Debtor has extended the self-paid coverage available under their group health plan for an extra 30 days past the date other employees' plan coverage terminated, and made special arrangements to ensure claims can be made, processed (and where

properly payable, paid). The Debtor also has made arrangements for an affiliated company to continue these arrangements for such bargaining unit employees and dependents.

(3) Pension Plans: The Debtor has made arrangements to (a) fully vest all bargaining unit employees actively accruing service under the Pension Plans covering the employees represented by the Union at the Facilities as of October 1, 2006, who were furloughed as a result of the cessation of manufacturing operations, (b) recognize benefit accrual service through July 31, 2007 for those participants entitled to accrue benefit service under the Pension Plans, (c) recognize continuing vesting service under the Pension Plans, and (d) cause the Pension Plans to be assumed by Superior Fabrication, LLC, rather than be subjected to termination in connection with the Debtor's liquidation. The Debtor will have no further obligation for the Pension Plans under the Collective Bargaining Agreements after the assumption. The Union agrees to a complete freeze of benefit accrual service under the Pension Plans as of a date no later than July 31, 2007.

(4) Union General Release and Waiver: The Union agrees that it hereby waives any ability it may have to file a grievance or any charge with any governmental agency, file any lawsuit or initiate any proceeding in any court of law or with any other entity against the Debtor for any reason based on actions that have occurred at any time in the past up to and including the date of this Agreement; including but not limited to, the Union's ability to allege that the Debtor failed to bargain in good faith over the decision or the effects of the decision to close the Facilities. The Union also agrees that it will not assist anyone in filing such a charge or prosecuting any lawsuit against the Debtor, except to comply with any subpoena or other lawful process of a court or agency. The Union also agrees that it has resolved all claims against the Debtors of the Employees listed on Attachment 1 that arise out of the terms of the Collective Bargaining Agreements or with respect to the receipt of notice of plant shutdown for the Facilities; provided, however, that this Agreement shall have no impact whatsoever on the Freeman Claim unless Mildred Freeman agrees to participate in this Agreement on or before July 24, 2007, in which event, the Union represents that the proposed payment to Mildred Freeman will satisfy the Freeman Claim in full and that the Freeman Claim will be withdrawn, and the Union acknowledges that no payment will be made by the Debtor pursuant to this Agreement to Mildred Freeman until the Freeman Claim has been formally withdrawn.

(5) Termination of Collective Bargaining Agreements: Once the payments contemplated in Section 1 of this Agreement have been made, the Collective Bargaining Agreements shall be deemed terminated.

(6) Miscellaneous: The Debtor agrees that if an employee dies who would have been entitled to pay or insurance under this Agreement, it will pay and provide the insurance to the employee's estate.

(7) Bankruptcy: The obligation and ability to pay any money or provide any benefit under this Agreement, as well as the effectiveness of any waiver, is subject to and contingent upon the approval by the Bankruptcy Court. The Bankruptcy Court shall have

exclusive jurisdiction to determine as a core proceeding any dispute or controversy with respect to the interpretation or enforcement of this Agreement.


